AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GLENCOE TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND, WHICH LAND ABUTTS UPON THE CITY LIMITS.

WHEREAS, a certain petition dated <u>June 6</u>, 1967, requesting annexation of the territory hereinafter described was duly presented to the council on the 10th day of July, 1967, and,

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately half acre of platted, no part of which is included within the limits of an incorporated city, village, or borough, and,

WHEREAS, the petition was signed by allthe owners, and, WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed, and,

WHEREAS, the land described in the petition abuts upon the city limts at the Northerly boundary thereof;

The council of the city of Glencoe, Minnesota, ordains:

<u>Section 1.</u> The city council hereby determines that the annexation will be to the best interests of the city and of the territory affected;

that the territory described herein abuts upon the city limits and is urban or suburban in character; and

that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof: Lot One (1) and West Eleven and two/tenths (11.2) feet of Lot Eighteen (18) of Dahl's 2nd Addition, according to the map or plat thereof on file and of record in the Office of the Registrar of Titles in and for McLeod County, Minnesota;

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

<u>Section 4. Effective Date.</u> This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
