Ordinance No. 102 Village of Foley Benton County, Minnesota

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF FOLEY TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND

WHEREAS, a certain petition dated February 7, 1967, requesting annexation of the territory hereinafter described was duly presented to the council on the 10th day of February, 1967; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded ad described is approximately One-third (1/3rd) of an acre of platted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHERBAS, the petition was signed by all of the owners; and WHERBAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits at the southerly boundaries thereof;

The council of the Village of Foley, Minnesota, ordains:

Section 1. The village council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

Lot One (1), Block Four (4), of Foley Business Development Plat, according to the plat and survey thereof on file and of record in the Office of the Register of Deeds, in and for the County of Benton and State of Minnesota, which is of record in the names of THOMAS R. DEMARAIS and LOU K. DEMARAIS, husband and wife as joint tenants.

Section 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 5.
