ORDINANCE NO. 209

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LAND ABUTTING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS, MINNESOTA, LOCATED IN THE NE 1/4 OF THE NE 1/4 AND GOVERNMENT LOT 1, SECTION 34, TOWNSHIP 152, NORTH OF RANGE 50, TOTALLING 71.678 ACRES, MORE OR LESS.

The City Council of the City of East Grand Forks do hereby Ordain as follows:

Section 1. The corporate limits of the City of East Grand Forks, Minnesota, are hereby extended to include the tract of land hereinafter described. Said tract of land abuts the corporate limits of the City of East Grand Forks, and is described as follows, to-wit:

All that part of the Northeast Quarter of the Northeast Quarter (NE 1/4, NE 1/4) and Government Lot One (1), Section Thirty-Four (34), Township One Hundred Fifty-two (152) North of Range Fifty (50) West of the Fifth Principal Meridian, described as follows:

Commencing at the corner common to Sections 26, 27, 34 and 35 of Township 152 North of Range 50 West of the 5th Principal Meridian, thence South along the section line between sections 34 and 35, 975 feet; thence due West to the Red River of the North; thence North along said river to the section line between Sections 34 and 27; thence East along the last named section line to the point of beginning containing 71.678 acres, more or less, all being in the County of Polk and State of Minnesota.

Section 2. The total quantity of land embraced within the description of the said tract is 71.678 acres, more or less, and the sole owner thereof is the said City of East Grand Forks, Minnesota.

Section 3. The City Council hereby determines: (1) That said tract of land abuts the corporate limits of the City of East Grand Forks, Minnesota, and is not included within the corporate limits of any other municipality; (2) That the annexation will be to the best interest of the City of East Grand Forks, Minnesota, and of the territory affected; (3) That said tract of land is suitably conditioned for municipal government; (4) That said tract of land is urban in character.

Section 4. The corporate

limits of the City of East Grand Forks, Minnesota, are hereby extended to include the tract of land described in Section 1, and the same is hereby annexed to and included in the City of East Grand Forks, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. The City Clerk is hereby directed to file a copy of this Ordinance with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.

Section 6. This Ordinance takes effect upon its passage and publication, and the filing of the copies as directed in Section 5, and be given the Number 209.

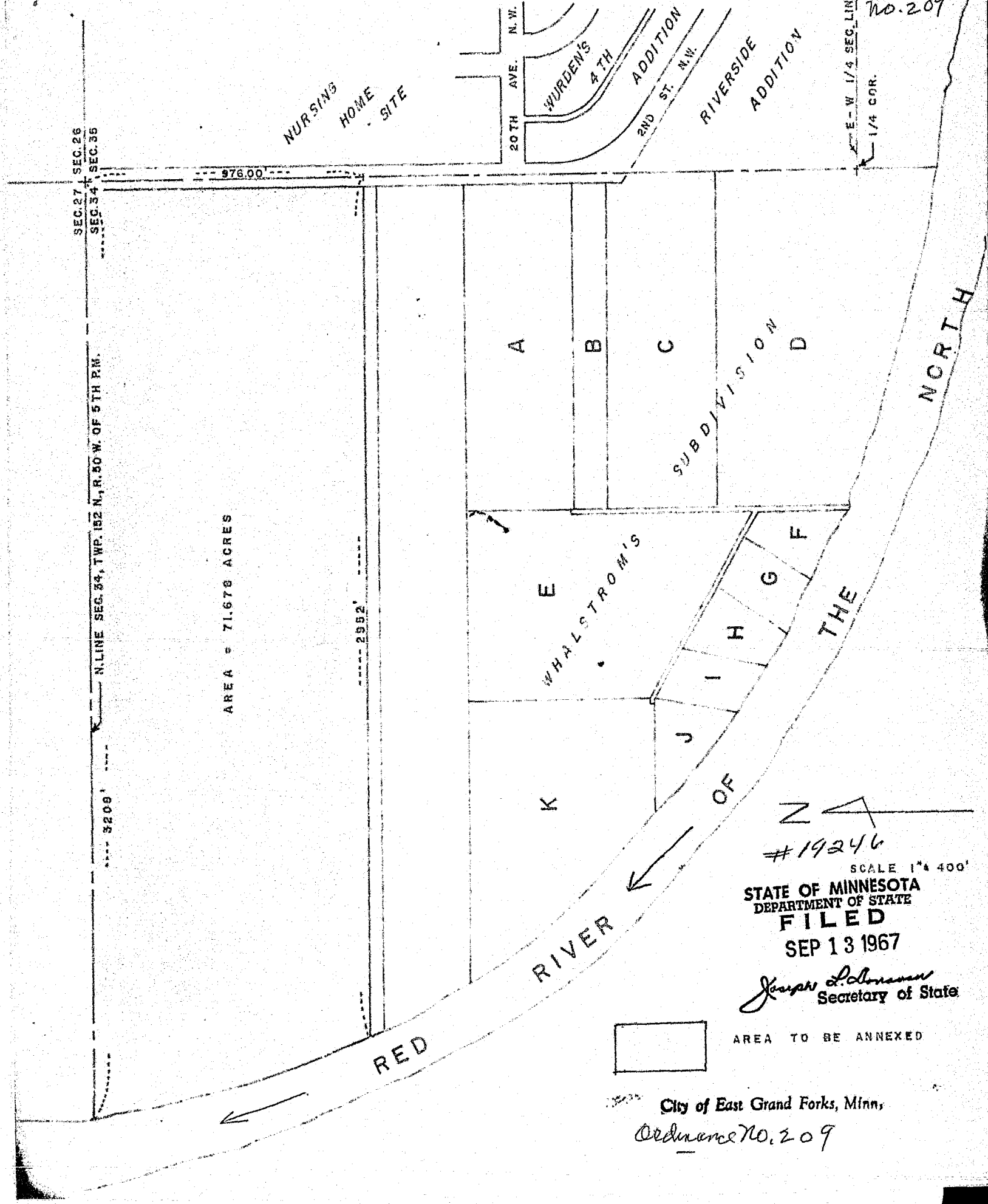

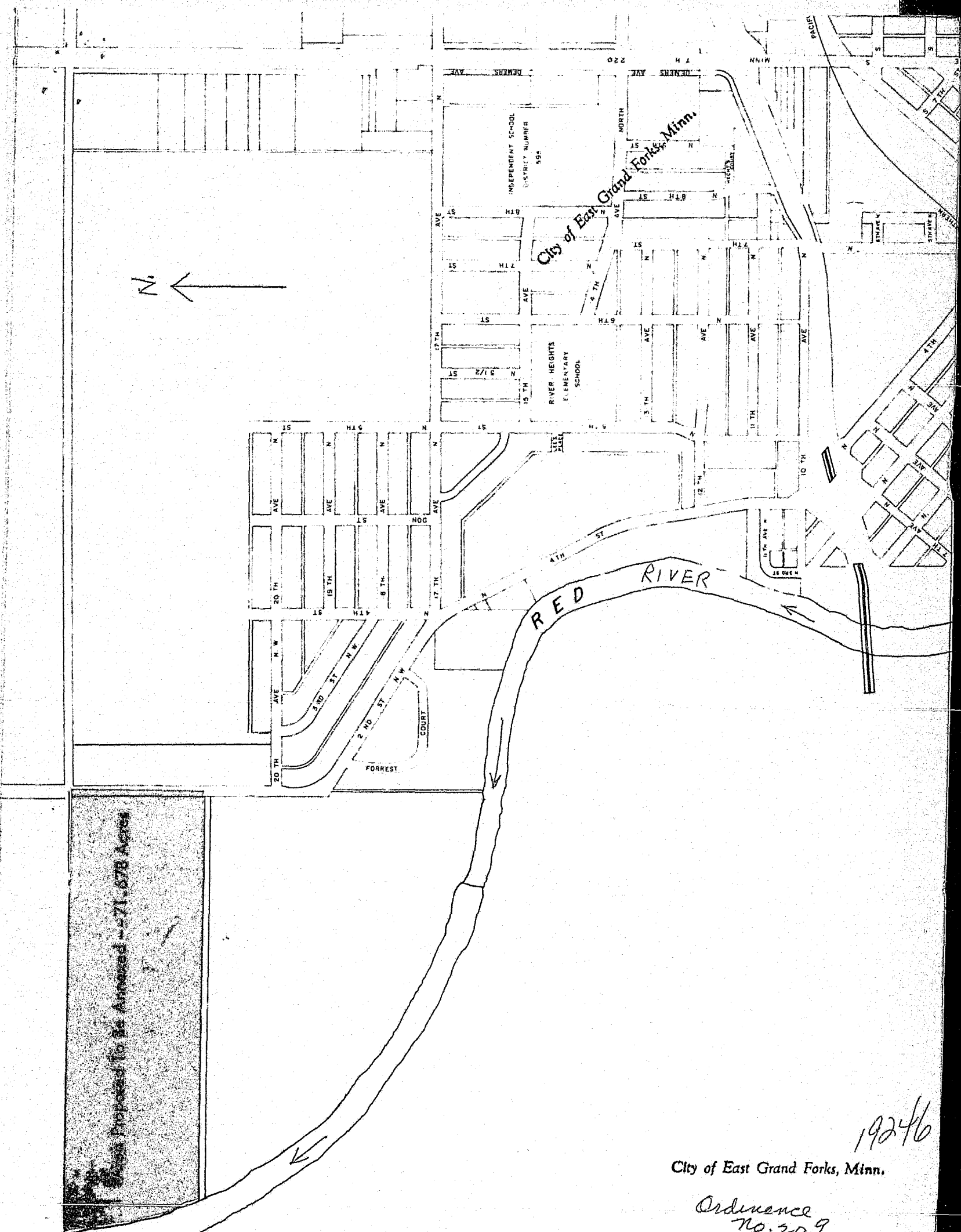
