WHEREAS, a Special City Election was duly held in the City of South St. Paul on August 29, 1967 for the purpose of submitting to the voters of said City and for their approval, the following propositions:

PROPOSITION NO. 1

"Shall the 1967 legislative act authorizing a 4 1/2 mill levy for parks, playgrounds, recreational facilities and recreational program purposes be approved?"

PROPOSITION NO. 2

"Shall the City Council be authorized to issue a special license permitting the sale and serving of intoxicating liquors on Sundays as defined in Minn. Laws 1967, Chap. 19, Sec. 1?"

WHEREAS, there are eight (8) election districts in the City of South St. Paul, to-wit:

The first (1st) precinct of the first (1st) ward,  
the second (2nd) precinct of the first (1st) ward,  
the first (1st) precinct of the second (2nd) ward,  
the second (2nd) precinct of the second (2nd) ward,  
the third (3rd) precinct of the second (2nd) ward,  
the fourth (4th) precinct of the second (2nd) ward,  
the first (1st) precinct of the third (3rd) ward,  
the second (2nd) precinct of the third (3rd) ward,

and the returns have been duly made by the Judges of said Election and from each of said election districts, and

WHEREAS, it appears from said returns and is the fact from said returns and the City Council of the City of South St. Paul have found and canvassed said returns as follows:

1. That there were cast in said election in said City for said Proposition No. 1, the following votes:

In favor of Proposition No. 1	<u>1,587</u>
Against Proposition No. 1	<u>1,722</u>

AND WHEREAS, pursuant to law, it is required that the majority of the votes cast at said election shall be in favor of said proposition before the same is adopted;

NOW THEREFORE, we find that the total number of votes cast in favor of Proposition No. 1 is 1,587, and the total number of votes cast against Proposition No. 1 is 1,722; and

WHEREAS, from said returns and the canvass of the said City Council, it appears that Proposition No. 1 did not receive the majority of all the votes cast on said proposition at said election.

NOW THEREFORE, BE IT RESOLVED, that the City Council of said South Saint Paul does hereby find and declare that said Proposition No. 1 did not duly carry at said election and was not approved by the people of said City of South Saint Paul.

2. That there were cast in said election in said City for said Proposition No. 2, the following votes:

In favor of Proposition No. 2	<u>2,257</u>
Against Proposition No. 2	<u>1,060</u>

AND WHEREAS, pursuant to law, it is required that the majority of the votes cast at said election shall be in favor of said proposition before the same is adopted.

NOW THEREFORE, we find that the total number of votes cast in favor of Proposition No. 2 is 2,257, and the total number of votes cast against Proposition No. 2 is 1,060;

WHEREAS, from said returns and the canvass of the said City Council, it appears that Proposition No. 2 did receive the majority of all the votes on said proposition at said election.

BE IT RESOLVED that the following proposed Ordinance be approved and given its second reading and placed upon its final passage, approval and publication, as follows:

ORDINANCE NO. 637

AN ORDINANCE RELATING TO THE SALE AND SERVICE OF INTOXICATING LIQUORS ON SUNDAYS

The City Council of the City of South St. Paul does ordain:

SECTION I.

Definitions. (a) "Establishment" as used herein shall mean premises to which on-sale licenses have been issued or hereafter may be issued for the sale of intoxicating liquors which are hotels or restaurants as defined in Laws 1967, Chapter 19, Section 1, and which have facilities for serving not less than 30 guests at one time.

(b) "Special On-Sale License" as used herein shall mean a special license permitting an establishment to sell or serve intoxicating liquors between the hours of 12:00 o'clock noon and 12:00 o'clock midnight on Sundays in conjunction with the serving of food provided that no liquor shall be served on Sundays other than to persons who are seated at tables.

SECTION II.

License Required. It is unlawful for any establishment, directly or indirectly, to sell or serve intoxicating liquor on Sundays without having first obtained a Special On-Sale License therefor.

SECTION III.

Special On-Sale License. The City Council may issue to establishments to which on sale licenses have been issued or hereafter may be issued for the sale of intoxicating liquors which are hotels or restaurants as defined in Laws 1967, Chapter 19, Section 1, and which have facilities for serving not less than 30 guests at one time.

SECTION IV.

Applications for License. Applications for Special On-Sale Licenses shall be made to the City Council in the same manner as applications for other licenses to sell intoxicating liquor.

SECTION V.

Term of License. Each license issued hereunder shall terminate on the 31st day of December following the issuance thereof.

SECTION VI.

License Fee. The annual license fee shall be \$200.00. If a portion of a year has elapsed when payment of the fee is made, a pro-rata fee shall be paid. In computing such fee, any unexpired fraction of a month shall be counted as one month.

SECTION VII.

Regulations. (a) An establishment licensed hereunder shall not, directly or indirectly, sell or serve intoxicating liquors on Sundays except between the hours of 12:00 o'clock noon and 12:00 o'clock midnight.

(b) The sale or service of intoxicating liquors by an establishment licensed hereunder shall only be in conjunction with the serving of food and only to persons who are seated at tables.

(c) The provisions of Section 820 of the Municipal Code of the City of South St. Paul not inconsistent with the provisions of this ordinance shall apply to Special On-Sale Licenses.

SECTION VIII.

This ordinance shall be in force and effect after its passage, approval and publication and at such time as the voters of the City authorize the City to issue such licenses.
