## ORDINANCE NO. 371

## Annexing Real Estate

WHEREAS, a certain petition dated April 6, 1964, requesting annexation of the land hereinafter described was duly presented to the council on the 6th day of April, 1964; and,

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 19.19 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and,

WHEREAS, the petition was signed by all of the owners of the real estate involved; and,

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and,

WHEREAS, the land described in the petition abuts upon the city limits at the southeasterly boundary thereof;

The council of the City of Moorhead, Minnesota, ordains:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof, said land described as follows: All that part of the Northwest Cuarter (NW2) of Section Fifteen (15), Township One Hundred Thirty-nine (139), Range Forty-eight (NB) that lies Southwesterly of Business Loop 94, formerly known as Highway 52, containing approximately 19.19 acres.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section h. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
