

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF WILLERNIE, WASHINGTON COUNTY, MINNESOTA, TO INCLUDE CERTAIN PLATTED AND UN-PLATTED LAND NOT EXCEEDING 200 ACRES

THE VILLAGE COUNCIL OF THE VILLAGE OF WILLERNIE, WASHINGTON COUNTY, MINNESOTA ORDAINS:

Section 1. A Petition having been filed with the Governing body of the Village of Willernie, Minnesota, by all in number of the following described real estate to have such land included within the Village of Willernie, Minnesota:

All that part of the North Half of the Southeast Quarter (N $\frac{1}{2}$ of SE $\frac{1}{4}$) of Section Twenty-nine (29), Township Thirty (30) Range Twenty-one (21) West, Lincoln Township, Washington County, Minnesota, described as follows:

The East Three hundred (300) feet of the West Six hundred fifty-three (653) feet of the following described parcel; Commencing at the Northwest corner of said Southeast Quarter (SE $\frac{1}{4}$); thence South along the Westerly line of said Southeast Quarter (SE $\frac{1}{4}$) a distance of Twenty-three and Fifty-five hundredths (23.55) feet to the Point of Beginning; thence continuing on same line One hundred (100) feet to a point; thence Easterly on a straight line to a point in the Easterly line of said Southeast Quarter (SE $\frac{1}{4}$) located One hundred sixteen and Seventy-three hundredths (116.73) feet South of the Northeast corner of said Southeast Quarter (SE $\frac{1}{4}$); thence North along said Easterly line One hundred (100) feet to a point; thence Westerly on a straight line to the Point of beginning.

Lots Eight (8) and Nine (9), Block Three (3), Third Addition to Forest Heights, Washington County, Minnesota, according to the plat thereof on file and of record in the Office of the Register of Deeds, Washington County, Minnesota; also easement to White Bear Lake, recorded in Book 93 of Deeds, page 396, in the office of the Register of Deeds of said County.

Lots Six (6) and Seven (7), Block Four (4), Third Addition to Forest Heights, according to the plat thereof on file and of record in the office of the Register of Deeds, Washington County, Minnesota.

Section 2. The petition is made and filed pursuant to the provisions of Subdivision 2 of Section 414.03 of Minnesota Statutes Annotated, with notice of the petition and the petition given to the Minnesota Municipal Commission, the Town of Lincoln and Board of County Commissioners of Washington County.

Section 3. A quantity of land embraced in the foregoing description does not exceed 200 acres.

Section 4. The Village Council hereby determines that the annexation will be to the best interests of the Village of Willernie, Minnesota, and of the territory affected; that the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village government.

Section 5. The corporate limits of the Village are hereby extended to include the property described in Section 1 and the same is hereby annexed to and included in the Village as effectually as if it had originally been a part thereof, together with that portion of Fairmount Avenue, Stillwater Road (County Road 12) and Crocus Avenue lying adjacent thereto.

Section 6. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.

Section 7. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 6.
