

ORDINANCE

An ordinance providing for annexation of certain land abutting the village upon petition of the majority of the owners in number of such land.

THE VILLAGE COUNCIL OF COKATO, MINNESOTA, ORDAINS:

Section 1. That pursuant to a petition by a majority in number of the owners of certain property comprising less than two hundred (200) acres, described as follows:

The south half of the SE 1/4 of the NE 1/4, Section 34, Township 119, Range 28, excluding therefrom the West 12 rods of the SE 1/4 of the SE 1/4 of NE 1/4 of said Section 34; and the east three-quarters of the north half of the SE 1/4 of the NE 1/4 of Section 34, Township 119, Range 28 west of U.S. Highway 12, excluding therefrom the west 200 feet thereof and also excluding therefrom beginning at a point 530 feet East and 33 feet South of the NE corner of the SE 1/4 of NE 1/4 of said Section 34; thence South 300 feet; thence East 15 feet; thence North 300 feet; thence West 15 feet to point of beginning.

the village council has unanimously determined that it is to the best interest of the village and to the best interest of the property to be annexed that it be annexed.

Section 2. That a hearing was duly held on August 21, 1967, pursuant to at least thirty days' posted notice on the proposed annexation of the tract hereinbefore described, and all persons desiring to be heard were heard.

Section 3. The tract hereinbefore described is, by this ordinance, declared to be annexed to the Village of Cokato.

Section 4. This ordinance shall take effect upon its passage and publication and upon the filing of a copy of this ordinance with the Municipal Commission of the State of Minnesota, the County Auditor of Wright County, and the Secretary of State of the State of Minnesota.
