ORDER

IN THE MATTER OF THE RESOLUTIONS OF THE VILLAGE OF COOK AND THE TOWN OF OWENS FOR THE SIMULTANEOUS DETACHMENT AND ANNEXATION OF CERTAIN PROPERTY UNDER M.S.A. 414.06

The Village of Cook has, by resolution of the Village Council at a regular meeting held on the 11th day of July, 1967, petitioned for the annexation of certain property and the Town of Owens has concurrently, by resolution of the town board at a regular meeting on the 11th day of July, 1967, petitioned to detach the same territory, pursuant to Minnesota Statutes 414.06.

The territory involved consists of:

Parcel I: The North 460 feet of the West 154 feet of the Northeast Quarter of the Northeast Quarter of the Southeast Quarter (NE¹/₂ of NE¹/₂ of SE¹/₂), of said section.

Parcel II: The East 97 feet of the West 524 feet of the North 460 feet of the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{2}$ of SE $\frac{1}{2}$), of said section. Parcel III: The plat of ART'S ADDITION located in the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{2}$ of NE $\frac{1}{2}$) of said section.

Parcel IV: The West half of the Northeast Quarter of the Southeast Quarter (NE4 of SE4) of said section excepting therefrom the following parcels: 1. Beginning in center of NE4 of SE4, Sec. 18, T62, R18; thence South 20 rods, thence West 16 rods; thence North 20 rods; thence East 16 rods to place of beginning.

2. Beginning at a point 668 feet 7 inches West of SE corner of NE¹/₂ of SE¹/₄, Sec. 18, T62, R18, on 1/16th line on South side of said NE¹/₂ of SE¹/₃; thence North 330 feet parallel to North and South line of East side of said NE¹/₂ of SE¹/₃; thence West 132 feet parallel to South line of said NE¹/₄ of SE¹/₄; thence South 330 feet parallel to East line of this parcel of land; thence East 132 feet to point of beginning. 3. Beginning at a point 800 feet 7 inches West of SE corner of NE¹/₄ of SE¹/₄, Sec. 18, T62, R18; on 1/16th line on South side of NE¹/₄ of SE¹/₄; thence North 330 feet parallel to North and South line on East side of said NE¹/₄ of SE¹/₄; thence West 264 feet parallel to South line of NE¹/₄ of SE¹/₄; thence South 330 feet parallel to South line of NE¹/₄ of SE¹/₄; thence North 330 feet parallel to South line of NE¹/₄ of SE¹/₄; thence North 330 feet parallel to South line of NE¹/₄ of SE¹/₄; thence North 330 feet parallel to South line of NE¹/₄ of SE¹/₄; thence South 330 feet parallel to East line of this parcel of land; thence East 264 feet to the point of beginning.

4. Beginning at a point 1064 feet 7 inches West of SE corner of NE \ddagger of SE \ddagger , Sec. 18, T62; R18; on the $1/16^{th}$ line of South side of said NE \ddagger of SE \ddagger , thence North 330 feet parallel to North and South line on East side of NE \ddagger of SE \ddagger ; thence West 264 feet; thence South 330 feet parallel to East line of this parcel of land; thence East 264 feet to point of beginning.

IT IS ORDERED: That the above described property be and the same hereby is detached from the Town of Owens and annexed to the Village of Cook, the same as if it had originally been a part thereof.
