

Ordinance No. 62

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO AND EXTENDING
THE CORPORATE LIMITS OF THE VILLAGE OF TRUMAN, MARTIN COUNTY, MINN.

BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF
TRUMAN, MINNESOTA, AS FOLLOWS:

SECTION 1. That a Petition presented to the Village
Council of the Village of Truman, Minnesota, requesting that prop-
erty hereinafter described be annexed to the Village of Truman,
has been signed by the owners of said property and the prospective
owners thereof; that said property abuts upon the corporate limits
of the Village of Truman, Minnesota; that it is so conditioned to
be properly subject to municipal government; that the property is
unplatted; that no part thereof exceeds two hundred (200) acres;
that the annexation will be to the best interest of the Municipality
and the territory affected; that said Petition is in accordance
with M.S.A., Section 414.03 and is in all things sufficient; that
said Petition has been filed with Westford Township, the Martin
County Board and the Municipal Commission of the State of Minnesota;
that the consent of Westford Township and the Martin County Board
have been given to said annexation thereby waiving the 30 day
period in which written objections may be filed.

SECTION 2. That the property set forth in said Petition
is located in the County of Martin, State of Minnesota, described
as follows, to-wit:

A tract of land in the Southeast Quarter of Section
4 in Township 104 North of Range 30 West of the Fifth
Principal Meridian in Martin County, Minnesota,
described as follows:

Commencing at the Southeast corner of the Southeast Quarter of Section 4, thence West along the South line of the Southeast Quarter of Section 4 a distance of 1009.5 feet to the point of beginning; (Said point being on the Northerly extension of the West line of Dewey Street in the Village of Truman, Minnesota.) thence North parallel with the East line of the Southeast Quarter of Section 4 a distance of 183.0 feet, thence West parallel with the South line of the Southeast Quarter of Section 4 a distance of 200.00 feet, thence South parallel with the East line of the Southeast Quarter of Section 4 a distance of 183.0 feet to a point on the South line of the Southeast Quarter of Section 4, thence East along the South line of the Southeast Quarter of Section 4 a distance of 200.0 feet to the point of beginning. Subject to an easement for roadway right-of-way, being a strip of land 33.0 feet in width lying adjacent to and North of the South line of the Southeast Quarter of Section 4.

Said tract containing 0.8 acres of land more or less including roadway easement.

and that said property become and the same hereby is, extended to and incorporated within the corporate limits of the Village of Truman, Martin County, Minnesota, and is hereby declared to be a part of the Village of Truman, Minnesota, as effectually as if the same had been originally a part thereof and that the corporate limits be and the same hereby are extended to include said property.

SECTION 3. That this Ordinance shall be in full force and effect from and after its passage and publication as required by law and the filing of a certified copy with the Municipal Commission, the County Auditor, and Secretary of State, and the Township Board of Westford Township in which said property is located. In addition, the Village Clerk is hereby directed to file a certified copy of this Ordinance in the Office of the Register of Deeds for Martin County, Minnesota
