ORDINANCE 107

amended

AN ORDINANCE AMENDING THE FIRST PARAGRAPH OF
ORDINANCE NUMBER 105, ENTITLED "AN ORDINANCE
ANNEXING CERTAIN UNPLATTED LAND TO THE VILLAGE
OF WAITE PARK, IN STEARNS COUNTY, MINNESOTA,"

WHEREAS, the Village Council in and for the Village of Waite
Park did on the 2nd day of May, 1967, following the necessary procedure
prescribed by law, enact an ordinance annexing certain real estate to
the Village of Waite Park, and,

WHEREAS, after the enactment of the ordinance it was discovered
that the legal description of the property described in said ordinance
was incorrect in that it described a road which constitutes part of the
boundary of said real estate as County Aid Road No. 81, when in fact
said boundary road had been changed from said County Aid Road No. 81 to
County Road 138 at the time the ordinance was enacted,

NOW, THEREFORE, for the purpose of correcting the error in
description, and not for the purpose of annexing any land other than
that already annexed, the Village Council in and for the Village of
Waite Park does hereby declare and ordain:

That part of the first paragraph of said ordinance number
105, which ordinance is entitled, "An Ordinance Annexing Certain
Unplatted Land to the Village of Waite Park, in Stearns County, Minne-
sota", which reads as follows:

"All of that part of the west one-half of the
northwest quarter of Section 17, Township 124
North, Range 28 West, lying southeast of County
Aid Road No. 81, and north of Trunk Highway No.
52,"

is hereby amended to read as follows:

All of that part of the west one-half of the
northwest quarter of Section 17, Township 124
North, Range 28 West, lying southeast of County
Road No. 138, and north of Trunk Highway No. 52.

This ordinance shall become effective from and after its
enactment and publication.


Dear Mrs. Fencis:

AN ORDINANCE AMENDING CERTAIN UNPLATTED LAND TO THE VILLAGE OF
WHITE PARK, IN STORMS COUNTY, MINNESOTA

WHEREAS, a certain petition having been duly filed with the Village Council in and for the Village of White Park, in Storms County, Minnesota, by the sole owner of that certain real estate situate in the County of Storms and State of Minnesota, described as follows, to-wit:

All of that part of the west one-half of the north-west quarter of Section 17, Township 124 North, Range 20 West, lying southeast of County Aid Road Co. 81, and north of Trunk Highway No. 52,

petitioning that said real estate be annexed to the Village of White Park, and,

WHEREAS, it was determined by said Village Council that said real estate is unplatted land, is less than 200 acres, and abuts the Village of White Park on its western boundary, and,

WHEREAS, upon receipt of said petition said Village Council filed copies of the same with the Minnesota Municipal Commission, the St. Cloud Township Board, and the Storms County Board, and within thirty days of said filing there were no written objections to said annexation submitted to the Village of White Park or to the Minnesota Municipal Commission, and,

WHEREAS, it has been determined by said Village Council that said annexation will be in the best interest of the Village of White Park and the above described property,

HEN, THEREFORE, the Village Council in and for the Village of White Park does hereby declare and ordain:

That the corporate limits of the Village of White Park, in Storms County, Minnesota, be and they hereby are extended to include that certain real estate hereinafter described, and the same is hereby annexed and included in the Village of White Park as effectually as if it had originally been a part thereof.
