

ORDINANCE NO. 401

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF OWATONNA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND ENTIRELY SURROUNDED BY LAND WITHIN THE MUNICIPAL LIMITS.

WHEREAS, The City Council of the City of Owatonna, Minnesota has been advised that the territory hereinafter described is entirely and completely surrounded by land within the municipal limits of the City of Owatonna; and

WHEREAS, the quantity of land embraced within the area described hereinafter and bounded as described contains 1.41 acres more or less of unplatted land, no part of which is included within the limits of an Incorporated City, Village, or Borough; and

WHEREAS, The governing body of the City of Owatonna, by virtue of Minnesota Statutes 414.03, Subd. 2, has been empowered to declare land completely surrounded by land within the municipal limits of the City of Owatonna to be annexed to the City of Owatonna.

NOW THEREFORE, The City Council of the City of Owatonna do ordain:

SECTION 1. The City Council hereby determines:

(1) That the annexation of the property hereinafter described will be to the best interests of the City of Owatonna and of the territory affected; and

(2) That the property described herein is completely surrounded by land within the municipal limits of the City of Owatonna, and is, or is about to become urban or suburban in character; and

(3) That none of said territories now included within the limits of the City, Village or Borough.

SECTION 2. Territory Annexed.

The corporate limits of the City of Owatonna are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the City of Owatonna as effectively as if it had originally been a part thereof:

Commencing at the Northeast Corner of the Northeast Quarter of Section 21, Township 107 North, Range 20 West, Steele County, Minnesota, thence West along the North line of said Section 21 395 feet to the point of beginning, thence South 153 feet, thence West 401 feet, thence North 153 feet, thence East 401 feet to the point of beginning. Said land being in Section 21, Township 107 North, Range 20 West, Steele County, Minnesota.

SECTION 3. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the Steele County Auditor.

SECTION 4. Effective Date. This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3 above.
