
Dear Mr. Stacy:

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES ADJOINING THE CITY LIMITS.

WHEREAS, a Petition was filed requesting the annexation of the territory hereinafter described, such petition was duly presented to the Common Council on the 22nd day of May, 1957, and

WHEREAS, the quantity of lands embraced within the area described in the petition and bounded as described is 10 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the petition was signed by all the owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city of Austin at the West boundary thereof;

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1) The City Council hereby determines 1) that the annexation will be to the best interests of the City and of the territory affected, 2) that the territory described herein abuts the city limits, and is about to become urban or suburban in character, and 3) that none of said territory is now included within the limits of any city, village or borough.

SECTION 2) The corporate limits of the City of Austin are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the city of Austin as effectually as if it had originally been a part thereof:

Beginning at the southeast corner of the southwest quarter of Section 4, Township 102 North, Range 19 West, Nowar County, Minnesota; thence northerly along the east line of said quarter section a distance of 462.0 feet; thence westerly at a deflection angle to the left of 89° 22' a distance of 540.54 feet; thence northerly at a deflection angle to the right of 89° 22' a distance of 123.5 feet; thence westerly in a line parallel to the south line of lot 1, Block 9, Sun Valley 1st Addition to the City of Austin, and also parallel to the south line of lot 2, Sun Valley 2nd Addition to the City of Austin, a distance of 252.0 feet; thence northerly a distance of 100 feet to the southwest corner of lot 1, Block 9, Sun Valley 1st Addition; thence westerly on a line parallel to the north line of said lot 1 until this line intersects the centerline of Turtle Creek, thence southeasterly along the centerline of Turtle Creek until the centerline intersects a line that is parallel to and 33.0 feet south of the north line of Section 4. This line lies in the northwest quarter of Section 9, Township 102 North, Range 19 West; thence easterly on this line until it intersects the east line of the northwest quarter of Section 9; thence northerly along this line 33.0 feet to the point of beginning.

SECTION 3) THE City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

SECTION 4) The Ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
