IN THE MATTER OF THE PETITION FOR THE DETACHMENT OF CERTAIN PROPERTY  
FROM THE VILLAGE OF MAYNARD, MINNESOTA

The petition for the detachment of property from the Village of Maynard, Chippewa County, Minnesota, came on for hearing before the Minnesota Municipal Commission in the Maynard Village Hall, Maynard, Minnesota, on the 25th day of October, 1967.

Robert W. Johnson, Chairman, and Arthur R. Swan, Member, attended the hearing.

The Commission having duly considered the testimony of the witnesses, the exhibits received in evidence and all other evidence and upon all the files and records, being fully advised in the premises, makes and enters the following:

FINDINGS OF FACT

I.

Due, timely and adequate legal notice of the hearing herein was published, served and mailed.

II.

That the requisite number of property owners have executed said petition.

III.

That the property is unplatted and used and occupied exclusively for agricultural purposes.

IV.

That the property is within the boundaries of the Village of Maynard, Minnesota, and is adjacent to said boundary thereof.

V.

That the detachment would not unreasonably effect the symmetry of the settled municipality and the land described herein is not needed for reasonably anticipated future development of said Village of Maynard.

CONCLUSIONS OF LAW

That the land described herein should be detached from the Village of Maynard, Minnesota, and that said property should become a part of the Township of Stoneham, County of Chippewa, State of Minnesota.

ORDER

IT IS ORDERED: That the following described land shall be detached from<sup>th</sup> the Village of Maynard, Minnesota, and become a part of Stoneham Township, Chippewa County, Minnesota, the same as if it had originally been made a part thereof:

Tract A


East 30 acres of the NW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 32, Township 117, Range 38


Tract B

All those parts of the SW $\frac{1}{4}$  of SE $\frac{1}{4}$ ; Sec 29, T117N, R38W described as follows: The East 330' of the South 363' of the West 660' and the West 330' of the South 513' except the West 82.5' of the South 264, also except the South 33' of the East 247.5' of the West 330' of the above said SW $\frac{1}{4}$  of the SE $\frac{1}{4}$  Sec. 29, T117N, R38W
