ORDINANCE No. 45

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ARLINGTON TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated August 7, 1967, requesting annexation of the territory hereinafter described was duly presented to the Council on the 7th day of August, 1967; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 14.2 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all owners, and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the East boundary thereof;

The Common Council of the City of Arlington, Minnesota, does ordain:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

Part of the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Ten (10), Township One Hundred Thirteen (113) North of Range Twenty-seven (27) West, Sibley County, Minnesota, described as follows:

Beginning at the intersection of the westerly projection of the south line of the Arlington Public Cemetery with the east line of the Schumann and Kill Addition to the City of Arlington, Minnesota; which point is 42.2 feet more or less, north of the Northeast Corner of Lot One (1) of Block Four (4) of said Addition; thence easterly and along the south line of the Arlington Public Cemetery, 610 feet more or less, to the Southeast corner of said cemetery; thence southerly on a line parallel with the said east line of the said Schumann and Kill Addition, 1013.9 feet more or less to the South line of said Section Ten (10); thence westerly along the south line of said section, 610 feet more or less to the southeast corner of the said Schumann and Kill Addition; thence north along the east line of said Addition, 1012.1 feet to the point of beginning and containing 14.2 acres of land more or less.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date of Annexation. This ordinance takes effect thirty days after its passage and publication and the filing of certified copies as directed in Section 3.
