ORDINANCE NO. 93

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF LINDSTROM, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES IN AREA ABUTTING THE VILLAGE LIMITS.

WHEREAS, a certain petition dated August 30, 1967, request-annexation of certain territory was duly presented to the Council on the 5th day of September, 1967.

WHEREAS, the quantity of land embraced within the area described in the amended petition and bounded as described as approximately 3 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and

WHEREAS, the petition was signed by all of the owners of the land proposed to be annexed as hereinafter described, and

WHEREAS, the land described in the petition abuts upon the Village limits at the

~~northwesterly boundary thereof, and~~
WHEREAS, copies of said Petition have been filed with the Municipal Commission, the Town Board of Town of Chisago Lake, and the Chisago County Board of County Commissioners, said Town and County being the Town and County in which all of the land proposed to be annexed is located, and

WHEREAS, the boundaries of no other municipality abut upon the boundaries of the land to be so annexed, and

WHEREAS, no written objections to said annexation have been submitted to the Municipal Commission or the Village of Lindstrom Board of by the Chisago Lake Town Board or the Chisago County/Commissioners within thirty (30) days after said filing and the time allowed

pursuant to law, and

WHEREAS, no petition for incorporation or annexation is pending before the Municipal Commission including all or any part of the land proposed to be annexed and herein described;

The Council of the Village of Lindstrom, Minnesota, ordains:

Section 1. The Village Council hereby determines (1) that the annexation will be to the best interests of the Village and of the territory affected; (2) that the territory described herein abuts upon the Village limits and is urban in character; and (3) that none of said territory is now included within the limits of any incorporated city, village or borough, is unplatted and does not exceed 200 acres in area.

Section 2. Territory annexed. The corporate limits of the Village are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof:

All that part of Lot Six (6), Section Thirty-four (34), Township Thirty-four (34), Range Twenty (20), Chicago County, Minnesota, described as follows, to-wit:

Beginning at the Northwest corner of Lot 3, Block 1, Andrews Beach, according to the plat thereof on file in the Office of the Register of Deeds in and for said County; thence on an assumed bearing of North $88^{\circ} 02'$ East along the North line of Andrews Beach, 739.0 feet to a point on the Easterly line of a newly established public road; thence North $3^{\circ} 44'$ West along the Easterly line of said road 80 feet to the point of beginning of the tract herein described; thence continuing North $3^{\circ} 44'$ West along said road line a distance of 260.45 feet; thence North $80^{\circ} 0'$ East a distance of 332.05 feet; more or

less, to the shoreline of North Center Lake; thence southerly along said shore line to the point of intersection thereof with a line that bears North 88° 02' East from the point of beginning of the tract herein described; thence South 88° 02' West, 276 feet more or less, to the point of beginning, together with the public roadway 66 feet in width abutting said property on the westerly side thereof.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor of Chisago County, Minnesota.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 3.
