ORDINANCE NO. 93

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF LINDSTROM, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES IN AREA ABUITING THE VILLAGE LIMITS.

WHEREAS, a certain petition dated August 30, 1967, requestennexation of certain territory was duly presented to the Council on the 5th day of September , 1967.

WHEREAS, the quantity of land embraced within the area described in the amended patition and bounded as described as approximately 3 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and
