ORDINANCE NO. 363

AN ORDINANCE ANNEXING CERTAIN TERRITORY KNOWN AS MAPLEWOOD PARK TO THE CITY OF WASECA, MINNESOTA.

THE COMMON COUNCIL OF THE CITY OF WASECA DO ORDAIN:

WHEREAS, the City of Waseca is the owner of land known as Maplewood Park hereinafter described in Section 1 of this Ordinance;

AND WHEREAS, said real estate is territory abutting on the City of Waseca, being contiguous to the lake bed of Clear Lake which is now within the corporate limits of the City of Waseca, having been annexed under Ordinance #349 of said City pursuant to Chapter 11 of the Laws of 1965 of the State of Minnesota;

AND WHEREAS, said real estate is not included in any other municipality;

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF WASECA, MINNESOTA pursuant to the authority and provisions of Section 414.03 Minnesota Statutes annotated:

Sec. 1

That there hereby is annexed to the City of Waseca, Minnesota the following described real estate in the County of Waseca and State of Minnesota, to-wit:

Blocks one, two, three, four, five, six, seven, eight, nine, ten and eleven, in and of Maplewood Park, according to the plat of said Maplewood Park on file and of record in the office of the Register of Deeds in and for the County of Waseca and State of Minnesota.

Also, that tract or parcel of land marked on said plat of said Maplewood Park as "Assembly Grounds", and around the said tract of land so designated as "Assembly Grounds" the said hereinbefore mentioned lie.

Also, all the right, title and interest in and to all the lots, tracts and parcels of land described in that certain Trust Deed bearing date, December 6, A.D. 1888, executed and delivered by the Maplewood Park Association, a corporation, to Benedict S. Lewis, et al, and recorded in the office of the Register of Deeds, in and for the County of Waseca and State of Minnesota, on July 29th A.D. 1890, at ten o'clock A.M. in Book Number Two of deeds on pages

184, 185, 186 and 187 thereof.

Also, all the right, title and interest of the above named Edward A. Everett, in and to the property described in that certain Sheriff's certificate of redemption made and executed by George H. Goodspeed, as Sheriff of the County of Waseca and State of Minnesota, on the 24th day of February A.D. 1896 and recorded in the office of the Register of Deeds in and for the County of Waseca and State of Minnesota on the 24th day of February A.D. 1896 in Book No. Five (5) of Deeds on page 370 thereof.

Also, all right, title and interest in and to each and every tract, piece, lot or parcel of land forming a part of, or included in the plat of Maplewood Park in the County of Waseca and State of Minnesota, according to the survey and plat thereof on file and of record in the office of the Register of Deeds in and for the County of Waseca and State of Minnesota.

Also every tract, piece, lot or parcel of land forming a part of or included in the plat of Maplewood Park in the County of Waseca and State of Minnesota according to the survey and plat thereof on file and of record in the office of the Register of Deeds in and for the County of Waseca and State of Minnesota.

Sec. 2

That a certified copy of this Ordinance shall be filed with the Minnesota Municipality Commission, the Secretary of State of the State of Minnesota, the Auditor of the County of Waseca County, Minnesota, and the Register of Deeds of said County and State.


Sec. 3

That this Ordinance shall be in effect from and after the filing specified in Section 2 hereof and the publication of this Ordinance as provided by law.


