ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED ACRES, PURSUANT TO M.S.A. SECTION 414.03, SUBDIVISION 2, AND ALL LAWS AMENDATORY AND SUPPLEMENTARY THERETO, AND IN ACCORDANCE WITH THE RULES OF PROCEDURE OF THE MUNICIPAL COMMISSION.

The City of Mankato, Minnesota, does ordain:

I.

A Petition has been filed with the City Clerk of the City of Mankato, Minnesota, by Robert H. and Phyllis Ryan, 133 Agency Road; Robert O. and Lois Barnett, 2 Petticoat Lane; Jack K. and Ardyth Carpenter, 3 Petticoat Lane; Donald G. and Elizabeth Harrer, 4 Petticoat Lane, and Vernon L. and Kathryn Hanson, 5 Petticoat Lane, of the County of Blue Earth and State of Minnesota, as owners of the following described property set opposite their names, to have such lands included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

Robert H. and Phyllis Ryan 133 Agency Road:

Beginning at a point South 25° 6' West Six Hundred Eighty-two and 75/100 (682.75) feet from a point on the East and West " .. Quarter Section line Nine Hundred Ninetyone and 25/100 (991.25) feet East of the center of Section Seventeen (17), Town-ship One Hundred Eight (108) North, Range Twenty-six (26) West, thence South 27° 35' East Forty and 2/10 (40.2) feet, thence South 41° 11' West One Hundred Sixty-two (162) feet, thence North 42° 20' West One Hundred Seventy-seven (177) feet, thence North 41° 11' East Two Hundred Ten (210) feet, thence South 27° 35' East One Hundred Forty-eight and 6/10 (148.6) feet to the place of beginning, containing in all 75/100 acres more or less. Beginning at a point in the center of the Agency Road, South 22 degrees 30 minutes West and 708 feet distant from the point on the East and West quarter line of Section Seventeen (17), Township One Hundred Eight (108), Range Twenty-six (26) West, said point on the quarter line being a stone monument and is 991.25 feet East of the center of said Section; thence South 41 degrees 11 minutes West 162 feet, thence North 42 degrees 20 minutes West 177 feet, thence South 41 degrees 11 minutes West 10 feet, thence South 42 degrees 20 minutes East 187 feet; thence North 41 degrees 11 minutes East 169.4 feet; thence North 27 degrees 35 minutes West 10 feet to the point of beginning, containing 0.08 acres more or less;

thence North 48° 16' East 196 feet, thence
North 27° 35' West 90 feet to the point of
beginning, containing .34 acres more or less,
all the above described tract being located
in the Northwest Quarter (NWM) of the Southeast Quarter (SEM) of Section 17, Township
108, Range 26.

Robert O, and Lois Barnett 2 Petticoat Lane:

Lot Two (2), Auditor's Plat Forty-Seven (47) according to the Plat thereof on file and of record in the office of the Register of Deeds for Blue Earth County.

Jack K. and Ardyth Carpenter 3 Petticoat Lane:

Lot Three (3), Auditor's Plat Forty-Seven (47) according to the Plat thereof on file and of record in the office of the Register of Deeds for Blue Earth County.

Donald G. and Elizabeth Harrer 4 Petticoat Lane:

Lot Four (4) of Auditor's Plat Forty-Seven (47) according to the Plat thereof on file and of record in the office of the Register of Deeds within and for said County, State of Minnesota.

A part of Lot Five (5), Auditor's Plat Forty-Seven (47) described as follows, to-wit: Commencing at the Southwest corner of said Lot Five (5); thence Southeasterly along the Southwesterly boundary line of said Lot Five (5) a distance of 120 feet; thence Northeasterly along the Northwesterly boundary line of a private driveway as shown on Auditor's Plat Forty-Seven (47) a distance of 35 feet; thence Northwesterly parallel with the Southerly boundary line of said Lot Five (5) to the Northwesterly boundary line of said Lot Five (5); thence along the Northwesterly boundary line to the place of beginning. The same being extension of the private driveway as shown on said Auditor's Plat Forty-Seven (47).

Also right-of-way and easement over private road of Arnold Meyer for the purpose of ingress to and egress from said conveyed premises and for the purpose of maintaining a water pipe thereon. Private road is to be maintained by Donald G. Harrer and other owners of lots in Auditor's Plat Forty-Seven (47) at their own expense.

Vernon L. and Kathryn Hanson 5 Petticoat Lane:

Reserving to Arnold Meyer, his heirs and assigns forever, a perpetual easement to maintain a tile line along the easterly boundary of Lot Four (4) connecting with and extending in Lot Five (5). Also a right to maintain and keep in repair or rebuild, if necessary, said tile line.

Lot Five (5) of Auditor's Plat Forty-Seven (47) except that part of said Lot Five (5) described as follows: Commencing at the Southwest corner of said Lot Five (5); thence Southeasterly along the Southwesterly boundary line of said Lot Five (5) a distance of 120 feet; thence Northeasterly along the Northwesterly boundary line of a private driveway as shown on Auditor's Plat Forty-Seven (47) a distance of 35 feet; thence Northwesterly parallel with the Southerly boundary line of said Lot Five (5) to the Northwesterly boundary line of said Lot Five (5); thence along the Northwesterly boundary line to the place of beginning.

TT.

The quantity of land embraced within the foregoing descriptions is unplatted and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the southerly boundary of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000, pursuant to the last census. That it appears from the records of the Clerk of the City of Mankato, Minnesota, that copies of the petition asking for annexation were filed with the Minnesota Municipal Commission, the Mankato Township Town Board, and the Blue Earth County Board, and that more than thirty days have elapsed since said filing and that no objections to said annexation were submitted.

III.

The City Council of Mankato, Minnesota, hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tracts or parcels of land are so conditioned as properly to be subjected to city government and are hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota are hereby extended to include said property.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and this ordinance takes effect ten (10) days after its passage and publication and upon the filing of certified copies, as herein described.
