

AN ORDINANCE relating to the annexation of the SW $\frac{1}{4}$ of Section 12, of Township 139 North, of Range 45 West, less 12.4 acres more or less in the southeasterly part thereof situated on the easterly, southeasterly and southerly side of the Buffalo River.

The Village Council of the Village of Hawley ordains as follows:

Section 1. The following described land owned by the Village of Hawley, abutting said Village, all of which is located in the County of Clay, State of Minnesota, is hereby added to, taken into and made part of the Village of Hawley, to wit: The SW $\frac{1}{4}$ of Section 12, of Township 139 North, of Range 45 West, less 12.4 acres more or less in the southeasterly part thereof situated on the easterly, south-easterly and southerly side of the Buffalo River.

Section 2. On this Ordinance taking effect the corporate limits and boundary lines of the Village of Hawley shall be extended to include the westerly, southerly, southeasterly and easterly lines and sides of said land including the middle of the channel of the Buffalo River.

Section 3. This Ordinance shall take effect and be in force from and after its publication in the official newspaper.
