COUNCILMAN 3273

AN Ordinance Amending, to the City of Shakopee Certain Lands Described Heretofore Located
in Eagle Creek Township, Scott County, Minnesota

WHEREAS, The East 5/8ths of the North Half of the Southeast Quarter in Section 6,
Township 115, Range 22, Scott County, Minnesota, abuts the City of Shakopee and is not
included in any other municipality, and the said tract is 75% or more bordered on
three sides by the City of Shakopee, and

WHEREAS, It would be to the best interests of all parties concerned that said
tract be annexed by the City of Shakopee and thus become a part of the City of Shakopee,
and,

WHEREAS, The Common Council of the City of Shakopee by resolution passed on the
9th day of May, 1967, served notice of intention upon Eagle Creek Township pursuant to
MCA 414.03(2) of the City's intention to annex said land above described and giving
notice that, if no objections on the part of Eagle Creek Township were forthcoming
within a period of 60 days from and after the service of a certified copy of said
resolution upon the Township of Eagle Creek, the City of Shakopee would proceed to
annex the land to the City of Shakopee by ordinance as provided by law; and that, if
objections were filed, the City would request the Municipal Commission of the State of
Minnesota to conduct a hearing according to Section 414.04 MCA, and

WHEREAS, A certified copy of said resolution was duly served upon Eagle Creek
Township on the 22nd day of May, 1967, and

WHEREAS, A resolution of the Town Board of Eagle Creek Township, Scott County,
Minnesota, objecting to the annexation of the above described property to the City of
Shakopee, was duly passed by the Town Board on the 19th day of June, 1967 and a certified
copy of said resolution was served upon the City of Shakopee, and

WHEREAS, Subsequent thereto, the City of Shakopee by resolution requested the
Municipal Commission of the State of Minnesota to conduct a hearing on the proposed
annexation to the City of Shakopee of said lands located in Eagle Creek Township, Scott
County, Minnesota, and pursuant thereto the Municipal Commission duly set a hearing
thereon for October 9, 1967 at 12 A.M. in the City Hall in the City of Shakopee,
Minnesota, and

WHEREAS Under date of October 3, 1967 the Town Board of Eagle Creek withdrew its
objection to the proposed annexation and the proposed hearing scheduled by the said
Municipal Commission was cancelled on October 5, 1967.

THE COMMON COUNCIL OF THE CITY OF SHAKOPEE DOES ORIGINATE:

SECTION I. Amendment of Part of Eagle Creek Township

That all that part of Eagle Creek Township described as the last 5/8ths of the North Half of the Southeast Quarter, Section 6, Township 115, Range 22, Scott County, Minnesota is hereby annexed to and made a part of the City of Shakopee, County of Scott and State of Minnesota.


SECTION II. Effective Date

This ordinance shall be in force and effect from and after 30 days after its passage and publication.


SECTION III. Recordation and Filing


The City Recorder of the City of Shakopee is authorized and instructed, immediately upon this ordinance becoming effective, to file a certified copy hereof with the Minnesota Municipal Commission and a certified copy hereof with the County Auditor of Scott County, Minnesota, and a certified copy hereof with the Secretary of State of the State of Minnesota, and a certified copy hereof with the Registrar of Deeds and/or Registrar of Titles of Scott County, Minnesota, as may be required.
