

ORDINANCE # 343

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LITCHFIELD, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated August 28th, 1967, requesting annexation of the territory hereinafter described was duly presented to the Council on the 2nd. day of October, 1967; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately Seven (7) acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all the owners of said land, and;

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the East boundary thereof;

The Council of the City of Litchfield, Minnesota ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof; being approximately Seven (7) acres of land described as follows:

A part of the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section Twelve (12), Township One Hundred Nineteen North (119-N), Range Thirty-one West (31-W), described as follows, to-wit: Commencing at a point 467 feet North of the Southwest corner of said Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ of SE $\frac{1}{4}$), thence due North along the East boundary line of Gorman Avenue in the City of Litchfield, a distance of 467 feet; thence due East 467 feet; thence due South 467 feet; thence due West 467 feet to the point of beginning, containing five (5) acres, more or less.

Part of the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section Twelve (12), Township One Hundred Nineteen North (119-N). Range Thirty-one West (31-W) described as follows, to-wit: Beginning at a point 934.0 feet North of the Southwest corner of said Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ of SE $\frac{1}{4}$), thence continuing due North along the East boundary line of Gorman Avenue in the City of Litchfield a distance of 208.7 feet; thence due East 467.0 feet; thence due South 208.7 feet; thence due West 467.0 feet to the point of beginning.

All of the foregoing land being in Meeker County, Minnesota.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with Minnesota Municipal Commission, the Secretary of State, and County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
