

VILLAGE ORDINANCE NUMBER 74.

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE VILLAGE OF BUHL.

The Village Council of the Village of Buhl, St. Louis County, Minnesota, do ordain as follows:

Section One. That the following described platted lands known as the Second Addition to Buhl, abutting upon the incorporated Village of Buhl, St. Louis County, Minnesota be and the same are hereby annexed to such village and shall be and become a part of such village as effectually as if they had been originally a part thereof. Said land is more particularly described as follows: The Northeast quarter of the Southeast quarter (NE $\frac{1}{4}$ of the SE $\frac{1}{4}$) of Section Twenty (20), Township Fifty-eight (58), Range Nineteen (19), West, etc., St. Louis County, Minnesota, containing forty acres more or less, according to the U. S. Government Survey thereof.

Section Two. This ordinance is in pursuance of Session Laws of Minnesota of 1905, Chapter 220 as amended by Session Laws of Minnesota of 1909, Chapter 323.

Section Three. This ordinance shall be in force and effect from and after its due passage and publication and after certified copies thereof have been filed and recorded in the respective offices of the Register of Deeds and County Auditor of said St. Louis County and Secretary of State of Minnesota, as provided by law.
