

ORDINANCE NO. 201

AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF STAPLES AND INCORPORATING  
ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

SECTION 1. A petition has been filed with the governing body of the City of Staples, Minnesota by the owners of the following described tracts of real estate to have such tracts included within the City of Staples, Minnesota:

- Parcel 1. Lots Seven (7) and Eight (8) in Block Seventeen (17), O'Connor's Addition to Staples, Minnesota including all streets, alleys and utility easements.
- Parcel 2. Lots Nine (9) and Ten (10) in Block Seventeen (17), O'Connor's Addition to Staples, Minnesota including all streets, alleys and utility easements.
- Parcel 3. Lots Eleven (11) and Twelve (12) in Block Eighteen (18), O'Connor's Addition to Staples, Minnesota including all streets, alleys and utility easements.
- Parcel 4. Lots Three (3) and Four (4) in Block Four (4), O'Connor's Addition to Staples, Minnesota including all streets, alleys and utility easements.
- Parcel 5. Lots Eleven (11) and Twelve (12) in Block Seventeen (17) in O'Connor's Addition to Staples, Minnesota including all streets, alleys and utility easements.
- Parcel 6. The West Half (½) of Block Nineteen (19), O'Connor's Addition to Staples, Minnesota including all streets, alleys and utility easements.

SECTION 2. The quantity of land embraced within each of the foregoing described parcels and bounded as described is less than one acre, and the total of all of the parcels is less than two acres.

SECTION 3. Notice of the filing of the petition has been filed with the Staples Town Board, County Auditor of Todd County and with the Minnesota Municipal Commission at least 30 days prior to the first reading of this ordinance.

SECTION 4. All fees required to be paid by the petitioners have been duly paid.

SECTION 5. The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota, and of the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

SECTION 6. Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described by and the same is hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.

SECTION 7. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
