ORDINANCE EXENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN LAND NOT EXCEEDING TWO HUNDRED ACRES, PURSUANT TO CHAPTER 686, LAWS OF MINNESOTA 1959 SESSION AND ACTS AMENDATORY (MSA 414.03)

The City of Mankato, Minnesota does ordain:

Section 1

A petition has been filed with the City Clerk of the City of Mankato, Minnesota, by Clement W. Scheurer and Anastasia M. Scheurer, as sole owners of the following described real estate to have such land included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

Lot 1 and Lot 18, in Block 2, of Scheurer's Sunray Addition No. 3 to Mankato, according to the plat on file in the office of the Register of Deeds of said Blue Earth County.

Section 2

The quantity of land embraced within the foregoing description does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the South, East and West boundaries of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000, pursuant to the last census.

Section 3

The City Council of Mankato, Minnesota hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tract and parcel of land is so conditioned as properly to be subjected to city government and is hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota are hereby extended to include said property:

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor of Blue Earth County, Minnesota, and the Secretary of State of Minnesota; this ordinance takes effect 10 days after its passage and publication and upon the filing of certified copies, as herein provided.
