ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED ACRES, PURSUANT TO M.S.A. SECTION 414.03, SUBDIVISION 2, AND ALL LAWS AMENDATORY AND SUPPLEMENTARY THERETO, AND IN ACCORDANCE WITH THE RULES OF PROCEDURE OF THE MUNICIPAL COMMISSION.

The City of Mankato, Minnesota, does ordain:

I.

A Petition has been filed with the City Clerk of the City of Mankato, Minnesota, by Charles G. Atwood, Secretary-Treasurer, ATWOOD LAND COMPANY, as owner of the following described real estate, to have such lands included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

Beginning at a point on the North-South quarter line of Section 16, Township 108 North, Range 26 West, 290.00 feet North from the center of said Section 16; thence Southerly along said quarter line, 290.00 feet to the center of said Section 16; thence Easterly along the East-West quarter line of said Section 16, 895.00 feet; thence deflecting left 90°, 365.00 feet; thence deflecting left 22°, 220.00 feet; thence deflecting left 90°, 460.00 feet; thence deflecting left 12°, 50.00 feet; thence deflecting left 26°-35', 50.17 feet; thence deflecting left 29°-25', 65.00 feet; thence deflecting right 90°, 30.00 feet; thence deflecting left 90°, 180 feet more or less to the place of beginning.

II.

The quantity of land embraced within the foregoing description is unplatted and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the Southeasterly part of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000, pursuant to the last census. That it appears from the records of the Clerk of the City of Mankato, Minnesota, that copies of the pettition asking for annexation were filed with the Minnesota Municipal Commission, the Mankato Township Town Board, and the Blue Earth County Board, and that more than thirty days have elapsed since said filing and that no objections to said annexation were submitted.

III.

The City Council of Mankato, Minnesota, hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tracts and parcels of land are so conditioned as properly to be subjected to city government and are hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota are hereby extended to include said property.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and this ordinance takes effect ten (10) days after its passage and publication and upon the filing of certified copies, as herein described.
