

PROPOSED ORDINANCE NO. 150

ORDINANCE NO. 582

AN ORDINANCE ANNEXING A CERTAIN
TRACT OF LAND TO THE CITY

THE COUNCIL OF THE CITY OF ST. CLOUD HEREBY ORDAINS:

Section 1. That the council hereby finds that the City of St. Cloud has presented a petition to the council requesting the annexation to said city of that certain tract of land described in Section 4 hereof; that said city is the sole owner and in possession of said tract of land.

Section 2. That the council further finds that said tract of land immediately abuts upon the present boundary of said city, and that it is for the best interest of said city and of the inhabitants thereof that said petition be granted and that said tract of land be annexed to said City of St. Cloud and made a part thereof.

Section 3. That the Planning Commission of said city has recommended that said tract be annexed to the City of St. Cloud.

Section 4. That the certain tract of land, situated in the County of Stearns, State of Minnesota, described as follows, to-wit:

All that part of the SE 1/4 of the NW 1/4 of Section 8, in Township 124, Range 28 West lying easterly and southerly of the center of the Sauk River, containing 2.08 acres more or less, excepting and excluding therefrom the Southerly 100 feet of the above described tract, said excepted piece containing .39 acres more or less,

be, and the same hereby is, declared to be annexed to said City of St. Cloud and to be a part thereof.

Adopted by the Council of the City of St. Cloud at a regular meeting held November 6, 1967, by the following vote:
