WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described, is approximately three acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and,

WHEREAS, the petition was signed by all the owners, and,

WHEREAS, no objection to the annexation has been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed, and,

WHEREAS, the land described in the petition abuts upon the village limits along the Westerly and Southerly boundaries thereof:
