## ORDINANCE NO. 86

AN ORDINANCE ANNEXING TO THE VILLAGE OF LA CRESCENT IN HOUSTON COUNTY, MINNESOTA, TERRITORY ABUTTING ON SAID VILLAGE PURSUANT TO THE PROVISIONS OF SECTION 414.03, MINNESOTA GENERAL STATUTES, AS AMENDED

The Village Council of the Village of Ia Crescent, Houston County, Minnesota, ordains as follows:

1. The Church of the Crucifixion of La Crescent, Minnesota, as the sole owner of the real estate hereinafter described, duly petitioned the Village Council of this Village to have said real estate annexed to and included within said Village.

2. Said real estate abuts on said Village, is not included in any other municipality, is unplatted and does not exceed 200 acres in area.

3. The annexation of said real estate to said Village will be to the best interest of said Village, of said real estate and of the territory affected thereby.

4. Pursuant to the provisions of Section 414.03, Minnesota General Statutes as amended, it is hereby declared that the real estate hereinafter described is hereby annexed to, included within and made a part of the Village of Ia Crescent in Houston County, Minnesota, said real estate being situate in said County of Houston and described as follows, to-wit:

A tract of land in the southeast quarter of the southeast quarter  $(SE_{4}^{1})$  of  $SE_{4}^{1}$ ) of Section Nine (9) Township One Hundred Four (104) North, Range Four (4) West, Houston County, Minnesota, described as follows:

Commencing Six Hundred Seven (607) feet west of the northeast corner of the southeast quarter  $(SE_{4}^{1})$  of the southeast quarter  $(SE_{4}^{1})$ of Section Nine (9) Township One Hundred Four (104) North, Range Four (4) West, Houston County, Minnesota, at an iron pin on the north line of the forty, as the place of beginning; thence continuing west four hundred eleven and 75/100 (411.75) feet along said north line to a pipe Mt., thence south 8 degrees 30' west nine hundred and ninety-six (996) feet to an iron pin in the center of the highway; thence north 32 degrees 45' east, seven hundred nineteen and 17/100 (719.17) feet to an iron pin in the center of the highway; thence south 24 degrees 30' east four hundred eleven (411) feet to the place of beginning. Containing four and 97/100 (4.97) acres more or less.

Also a tract in the northeast quarter of the southeast quarter  $(NE_{R_{1}}^{1})$  of  $SE_{R_{2}}^{1}$ ) Section Nine (9) Township One Hundred Four (104) North Range Four (4) West, Houston County, Minnesota, described as follows:

Commencing Six Hundred Seven (607) feet west of the southeast corner of the northeast quarter of the southeast quarter  $(NE_{4}^{1} SE_{4}^{1})$  Section Nine (9) Township One Hundred Four (104) North, Range Four (4) West, Houston County, Minnesota, at an iron pin on the south line of the forty as the place of beginning; thence continuing west four hundred eleven and 75/100 (411.75) feet along said south line of the forty to a pipe Mt., thence north 8 degrees 30' east 56.2 feet to an iron pin in the center of the highway; thence southeasterly four hundred five (405) feet along the center line of the highway to the place of beginning, containing thirty-two (.32) hundredths of an acre more or less.

5. This ordinance shall become effective upon its passage and adoption and publication as provided by law and its filing as provided by Chapter 414, Minnesota General Statutes as amended.
