
Dear Ms. Rosevold:



ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNPLATTED LANDS NOT EXCEEDING TWO HUNDRED ACRES, PURSUANT TO M.S.A. SECTION 414.03, SUBDIVISION 2, AND ALL LAWS AMENDATORY AND SUPPLEMENTARY THERETO, AND IN ACCORDANCE WITH THE RULES OF PROCEDURE OF THE MUNICIPAL COMMISSION.

The City of Mankato, Minnesota, does ordain:

I.

A Petition has been filed with the City Clerk of the City of Mankato, Minnesota by V. R. Rooney and R. W. Kearney, as general partners of Kearney Properties, a limited partnership organized and existing under the laws of the State of Minnesota, who are owners of the following described property, to have such land included in the City of Mankato, Blue Earth County, Minnesota, to-wit:

Beginning at the Southeast corner of Section 8, Township 108 North, Range 26 West, thence West, along the South line of said Section 8, 1254.75 feet; thence North 1 degree 15 minutes East, and parallel to the West line of the Southeast Quarter (SE $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of said Section 8, 660.00 feet; thence West, and parallel to the South line of said Southeast Quarter (SE $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ), 66.00 feet to the West line of said Southeast Quarter (SE $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ); thence North 1 degree 15 minutes East, along said West line, 706.13 feet to a point 50.00 feet North of the North line of said Southeast Quarter (SE $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of said Section 8; thence North 89 degrees 58 minutes East, and parallel to said North line, 1318.12 feet to the East line of said Section 8; thence South 1 degree 09 minutes West, along said East line, 1367.65 feet to the point of beginning. Said tract containing 40.402 acres.

II.

The quantity of land embraced within the foregoing description is unplatted and does not exceed 200 acres and is not within the corporate limits of any city or village and is contiguous to and abutting upon a portion of the easterly boundary of the City of Mankato, Minnesota, an incorporated city, having a population of not less than 10,000 nor more than 30,000, pursuant to the last census. That it appears from the records of the Clerk of the City of Mankato, Minnesota, that copies of the petition asking for annexation were filed with the Minnesota Municipal Commission, the Mankato Township Town Board, and the Blue Earth County Board, and that the thirty day period as provided for by Section 414.03 of M.S.A., Subdivision 2, and the Rules of the Municipal Commission, having been duly waived by the Mankato Township Board, Blue Earth County Board, and the City of Mankato, and that no objections to said annexation were submitted.

III.

The City Council of Mankato, Minnesota, hereby determines that the annexation of the above described property will be to the best interests of the municipality and of the land affected and that the above described tracts or parcels of land are so conditioned as properly to be subjected to city government and are hereby annexed to and declared to be an addition to the City of Mankato, as effectually as if it had originally been a part thereof and the corporate limits of the City of Mankato, Minnesota are hereby extended to include said property.

The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and this ordinance takes effect ten (10) days after its passage and publication and upon the filing of certified copies, as herein described.
