ORDINANCE NO. 2-1967 AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF PAYNES-VILLE TO INCLUDE CERTAIN UNINCORPORATED UNPLAT-TED LAND NOT EXCEEDING 200 ACRES IN AREA, ABUT-TING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated July 25, 1967, re-questing annexation of the territory hereinafter described was duly presented to the Council on the 8th day of August, 1967, and WHEREAS, the quantity of

land embraced within the area described in the petition and bounded as described is approximately 62.3 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough:

WHEREAS, the petition was signed by the owner of all of said lands; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits at the southerly boundary thereof; The Village Council of the Village of Paynesville, ordains:

Section 1. The Village Council hereby determines:

That the annexation 1 . . . will be to the best interest of the Village and of

the territory affected. 2. That the territory described herein abuts upon the Village limits and is about to become urban or suburban in character. That none of said territory is now included within the limits of any city, village, or borough. TERRITORY Section 2.
