
Dear Mr. Schaele:

ORDINANCE # 51

An Ordinance Extending the Corporate Limits of the Village of Hamburg, to Include Certain non-platted lands, Not Exceeding 200 acres.

Section 1. A Petition having been filed with the Governing body of the Village of Hamburg, by William Mueller and Sons, the owner of the following described real estate to have such lands included within the Village of Hamburg, Minn.,

Commencing at the South Quarter corner of Section 28 Township 115, North Range 26 West; thence due North along the West line of the Southeast Quarter of said Section 28 for 33.00 feet; thence South 89°39' East along the North line of County State Aid Highway #5 for 434.00 feet to the point of beginning of the tract to be here described; thence due North parallel with the said West line of the Southeast Quarter of Section 28 for 150.00 feet; thence North 89°39' West, parallel with the said North line of County State Aid Highway #5 for 110.00 feet; thence due North parallel with the said West line of the Southeast Quarter of Section 28 for 620.00 feet; thence South 89°39' East parallel with the said North line of County State Aid Highway #5 for 300.00 feet; thence due South parallel with the West line of the Southeast quarter of Section 28 for 620.00 feet; thence North 89°39' West parallel with said North line of County State Aid Highway #5 for 90.00 feet; thence due South parallel with the said West line of the Southeast Quarter of Section 28 for 150.00 feet; thence North 89°39' West along the said North line of County State Aid Highway #5, for 100.00 feet to the point of beginning.

Saving and excepting from the foregoing all that portion thereof lying and being in the Village of Hamburg, Minnesota

Section 2. The quantity of land embraced within the foregoing description and bounded as described is 4.61 acres.

Section 3. The Village Council hereby determines (1) That the annexation will be to the best interest of the Village of Hamburg, Minnesota, and of the territory affected; (2) that the territory described herein abutts upon the Village of Hamburg, and is so conditioned as properly to be subjected to Village Government.

Section 4. Therefore, the Village of Hamburg, Minn., hereby ordains and declares that the property hereinbefore described be, and the same is hereby annexed to and included in the Village of Hamburg, Minnesota as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
