IN THE MATTER OF THE PETITIONS FOR THE DETACHMENT OF CERTAIN LAND FROM
THE VILLAGE OF GREENWALD, MINNESOTA

ORDER

The Minnesota Municipal Commission received a petition for the detachment of land from the Village of Greenwald by the owners of said land on February 8, 1968. A petition for the detachment of the same land was filed by the Village of Greenwald.

The territory involved consists of the following:

Tract A

The North One-half of the Southwest Quarter (N $\frac{1}{2}$ SW $\frac{1}{4}$), Section Thirty-two (32), Township One Hundred Twenty-five (125) North, Range Thirty-three (33) West.

Tract B

The East One-half of the Southwest Quarter of the Northeast Quarter (E $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$), and the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$), Section Thirty-two (32), Township One Hundred Twenty-five (125) North, Range Thirty-three (33) West;

and the South Ten (10) acres of the following described:

The Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$) and the East One-half of the Northwest Quarter of the Northeast Quarter (E $\frac{1}{2}$ NW $\frac{1}{4}$ NE $\frac{1}{4}$), all lying southwesterly on Minnesota Highway #4 in Section Thirty-two (32), Township One Hundred Twenty-five (125) North, Range Thirty-three (33) West, which Tract B contains seventy (70) acres, more or less;

Tract C

The South One-half of the Northwest Quarter (S $\frac{1}{2}$ NW $\frac{1}{4}$) less the East Three (3) Rods thereof, in Section Thirty-two (32), Township One Hundred Twenty-five (125) North, Range Thirty-three (33) West, containing 78.50 acres, more or less, according to the Government Survey thereof.

The property is adjacent to the Village of Greenwald and said lands are unplatted and used exclusively for agricultural purposes. The petition is in proper legal form and sets forth the information required in Minn. Stat. 414.06 and upon the files and records, the
