
Dear Mr. Aanerud:

ORDINANCE NO 1858

An Ordinance extending the Corporate limits of the City of Albert  
Lea to include certain unincorporated, unplatted land not exceed-  
ing 200 Acres in area, abutting upon the City Limits

Introduced by Councilman Fred Brabec

WHEREAS, a certain petition dated December 11, 1967, requesting annexation  
of the territory hereinafter described was duly presented to the Council on the  
11th day of December, 1967; and

WHEREAS, the quantity of land embraced within the area described in the  
petition and bounded as described is 88.5 acres of unplatted land, no part  
of which is included within the limits of an incorporated city, village or  
borough; and

WHEREAS, the petition was signed by all owners and

WHEREAS, no objections to the annexation have been received from the  
Townboard, The County Board, or the governing body of any municipality  
whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the Northeastly  
City Limits.

THE COUNCIL OF THE CITY OF ALBERT LEA MINNESOTA DOES ORDAIN:

Sec. 1. The City Council hereby determines (1) that the annexation  
will be to the best interests of the City and of the territory affected  
(2) that the territory described herein abuts upon the City Limits and is  
about to become urban or suburban in character; and (3) that none of said  
territory is now included within the limits of any city, village, or borough.

Sec. 2. Territory Annexed: The corporate limits of the City are hereby  
extended to include the unplatted land described as follows and the same is  
hereby annexed to and included within the City as effectually as if it had  
originally been a part thereof:

Sec. 3. The City Clerk is hereby directed to file certified copies of  
this ordinance with the Minnesota Municipal Commission, the Secretary of State,  
and the County Auditor.

Sec. 4. That the above property is hereby zoned as C-2, General Commer-  
cial District.

Sec. 5. Effective Date: The ordinance takes effect upon its passage  
and publication and the filing of the certified copies as directed in Section  
3.
