
Dear Mr. Fahey:

RESOLUTION
No. 10-235-67

At a regular meeting of the City Council held October 24, 1967 Alderman Wigness seconded by Alderman Narverud introduced the following resolution and moved its adoption:

ORDINANCE NO. 329
AN ORDINANCE ANNEXING CERTAIN LANDS TO
THE CITY OF THIEF RIVER FALLS

The City Council of the City of Thief River Falls do hereby ordain as follows:

Section 1.

WHEREAS the sole owners of the following described premises situated in the County of Pennington and State of Minnesota, to-wit:

Lot Nineteen (19) and Lot Twenty (20), the boundary lines of which have been extended to the center of the Red Lake River, in Rustad's Subdivision of Government Lot Seven (7) and Eight (8) of Section Thirty-four (34), Township One Hundred Fifty-four (154) North, Range Forty-three (43) West of the Fifth Principal Meridian,

have petitioned the City Council to have such lands included within the municipality and have filed copies of said petition with the Municipal Commission of the State of Minnesota, and the Town Board of North and the County Board of the County of Pennington, State of Minnesota, and

WHEREAS the above described property abuts upon the boundaries of the City of Thief River Falls, and

WHEREAS no objection to the proposed annexation has been submitted,

NOW, THEREFORE, it is hereby determined that the annexation of said premises would be in the best interest of the City of Thief River Falls and of the territory affected and the above described premises are hereby declared annexed to the City of Thief River Falls.

Section 2.

This ordinance shall be in force and effect from and after its passage, approval, publication and filing with the Municipal Commission, the Pennington County Auditor and the Secretary of State of the State of Minnesota.
