**AN ORDINANCE ANNEXING CERTAIN TERRITORY TO AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF FAIRMONT, MINNESOTA**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FAIRMONT, MINNESOTA, AS FOLLOWS:

Section 1. That a petition presented to the City Council of the City of Fairmont, Minnesota, requesting that the property hereinafter described be annexed to the City of Fairmont has been signed by the owners of said property; that the said property abuts upon the corporate limits of the City of Fairmont, Minnesota; that it is so conditioned to be property subject to municipal government; that the unplatted part thereof does not exceed two hundred (200) acres in area; that the annexation will be to the best interest of the municipality and the territory effected; that said petition is made in accordance with M.S.A., Section 414.03, and is in all things sufficient.

Section 2. That copies of said petition were duly filed with the Municipal Commission of the State of Minnesota; the Town Board of the Town of Fairmont, Minnesota; the County Board of the County of Martin; that thirty (30) days have expired since the date of said filing, and that the City is in receipt of no objections to said petition, and that all provisions of M.S.A. Sec. 414.03 have been complied with.

Section 3. That the property set forth in said petition is located in the County of Martin, State of Minnesota, described as follows, to-wit:

A tract of land in the Southeast Quarter of Section 1 in Township 102 North of Range 31 West of the Fifth Principal Meridian in Martin County, Minnesota, described as follows:


Commencing at the Northeast corner of the Southeast Quarter of Section 1, thence South 0 degrees - 00 minutes West along the East Line of the Southeast Quarter of Section 1 a distance of 796.6 feet to the point of beginning; thence South 90 degrees - 00 minutes West a distance of 913.5 feet, thence South 0 degrees - 00 minutes West a distance of 519.4 feet to a point on the Northerly right-of-way line of the Chicago and North Western Railway Company, thence South 84 degrees - 40 minutes East along the Northerly railroad right-of-way line a distance of 917.4 feet to a point on the East line of the Southeast Quarter of Section 1 thence North 0 degrees - 00 minutes East along the East line of the Southeast Quarter of Section 1 a distance of 604.7 feet to the point of beginning. Subject to an easement for County State Aid Highway No. 14 being 50.0 feet in width and lying adjacent to and Westerly of the East line of the Southeast Quarter of Section 1.
