ORDINANCE # 222

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINDOM TO INCLUDE APPROXIMATELY 5 ACRES OF LAND ABUTTING THE CITY.

WHEREAS, a petition dated October 24, 1967, requesting annexation of land hereinafter described was presented to the Council on November 21, 1967; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 5 acres of land, no part of which is included within or abuts upon the boundary of any incorporated city, willage or borough; and

WHEREAS, the petition was signed by a majority of the property owners; and

WHEREAS, copies of the said petition have been duly filed with the Minnesota Municipal Commission, the town board of Great Bend Township and the County Board of Cottonwood County, being the town and county in which all of the land proposed to be annexed is located on November 24, 1967 and more than 30 days, have elapsed and written objection to the annexation have not been submitted to the city by the town board or the County Board and; whereas, a hearing was duly held by the City Council of Windom on the proposed annexation on February 6, 1968 after 30 days posted notice.

WHEREAS, the land described in the petition abuts upon the city limits at the Northerly boundary thereof;

BE IT ORDAINED BY THE CITY OF WINDOM, MINNESOTA AS FOLLOWS:

<u>SECTION 1:</u> The City Council hereby determines (1) that the annexation will be to the best interest of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban in characher; and (3) that none of the territory is now included within the limits of any other city, village or borough.

<u>SECTION 2:</u> The corporate limits of the city are hereby extended to include the platted and unplatted land hereinafter described and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof.

<u>SECTION 3:</u> The description of the land located in the Township of Great Bend in Cottonwood County, Minnesota, which is hereby annexed is as follows to wit:

> Lot 6, Billings Subdivision. All that part of Lots 13, 14, 15 and 16 of Billings Subdivision No. 2 lying Southerly of the right-of-way of U.S. Highway No. 71.

> All that part of the Southwest Quarter of Section 24, Township 105, Range 36 lying East of Lot 16, Billings Subdivision No. 2 and Southwesterly of U.S. Highway No. 71.

All the part of the Southwest Quarter of Section 24, Township 105, Range 36 lying Easterly of Lot 6 Billings Subdivision and Lot 1, Billings Subdivision No. 2 and Southwesterly of U.S. Highway No. 71. Ordinance # 222 (cont.)

All bEathearight-of-way of that certain public highway running on and along the South line of Section 24, Township 105, Range 36, known as 19th Street in the City of Windom, Minnesota, from its intersection with U.S.Highway No. 71 running Westerly to its intersection with Fourth Avenue extended in the City of Windom.

The right-of-way of U.S. Highway No. 71 on both sides of the center line of said highway from its intersection with 19th Street in the City of Windom to its intersection with the East line of Lot 1,2,3, and 4 of Billings Subdivision No.2.
