ORDINANCE # 223

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINDOM TO INCLUDE APPROXIATELY 180 ACRES OF UNPLATTED LAND ABUTTING THE CITY.

WHEREAS, a petition dated May 25, 1967 requesting annexation of land hereinafter described was presented to the Council on November 21, 1967 ; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 180 acres of land, no part of which is included with or abuts upon the boundary of any incorporated city, village or borough; and

WHEREAS, the petition was signed by all of the property owners; and

WHEREAS, copies of the said petition have been duly filed with the Municipal Commission the town board of Great Bend Township and the County Board of Cottonwood County, being the town and county in which all of the land proposed to be annexed is locate d on December 20, 1967, and more than 30 days have elapsed and written of jections to the annexation have not been submitted to the city by the town board or the County Board; and

WHEREAS, the land described in the petition abuts upon the city limits at the Southeasterly boundary thereof;

BE IT ORDAINED BY THE CITY OF WINDOM AS FOLLOWS:

SECTION 1: The City Council hereby determines (1) that the annexation will be to the best interest of the City and to the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban in character; and (3) that none of the territory is now included within the limits of any other city, village or borough.

SECTION 2: The corporate limits of the city are hereby extended to include the unplatted land hereinafter described and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof.

SECTION 3: The description of the land located in the township of Great Bend in Cottonwood County, Minnesota which is Hereby annexed is as follows to wit:

> All that part of Section Thirty-six (36), Township One Hundred Five (105) North, Range Thirty-six (36) West, Cottonwood County, Minnesota, described as follows, to wit: Lot Fourteen (14) in State Subdivision in said Section, all of the Northeast Quarter (NEA) of said Section lying West of County Road No. 43 except Blocks One (1) and Two (2) of Redding's First Addition to the City of Windom, and except the cemetery property bounded on the East by said County Road No. 43, and on the South by the South line of said Northeast Quarter (NEA) and being approximately 321,75 feet North and South and 354.75 feet East and West along said South boundary, and also all of the Northwest Quarter of the Southeast Quarter (NWASEA) of said Section.
