AN ORDINANCE ANNEXING CERTAIN LANDS TO
THE VILLAGE OF WYOMING

11-2767

WHEREAS, a Petition has been filed with the Village Council of the Village of Wyoming, Chisago County, Minnesota, requesting the annexation of certain lands to said Village of Wyoming, and

WHEREAS, the Village Council has determined that said annexation will be to the best interests of the said Village and of the territory affected,

THE VILLAGE COUNCIL OF THE VILLAGE OF WYOMING, MINNESOTA, does ordain as follows:

Section 1. That the following described real estate, to-wit:

The northerly 600 feet of the Northeast Quarter of the Northwest Quarter of Section 29, Township 33, Range 21, Chisago County, Minnesota, Lying easterly of Highway #61, is hereby declared annexed to the Village of Wyoming.

Section 2. This ordinance shall take effect immediately upon its passage and adoption.
