ORDINANCE NO. 67

AN ORLINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF WYOMING TO INCLULE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEPTING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS

WHEREAS, a cortain patition dated August 30, 1967, requosting annexation of the territory hereinafter described was duly presented to the Village Council on the 16th day of teptomber, 1967, and

WHEREAE, the quantity of land embraced within the area described in the potition consists of 27_6 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough, and which is described as follows:

That part of the Southeast Cuarter of the Northwest Cuarter (SE 1/4 of N. 1/4) Section Twenty-nine (29), Township Thirty-three (33) North, Range Twenty-one (21) West, Chisago County, Minnesota, Lying East of the Northern Pacific Reliway sight of way and South of the present Village limits of the Village of Wyoming,

and

WHEREAS, the petition was signed by all of the owners of said . property, and

WHIREAS, no objections to the annountien have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annound; and

The Council of the Villago of Synakay, Minnosota, ORIAINS:

Ection 1. The Village Council hereby determines that the annexation will be to the best interests of the Village and of the territory affected; that the territory described herein abute upon the Village limits and is or is about to become urban or suburban in character; and that none of caid territory is now included within the limits of any city, village, or berough.

Ecotion 2. IFERITORY ANNEXED. The corporate limits of the village are hereby extended to include the unplatted land above described and the same is hereby annexed to and included within the Village as effectually as if it had eriginally been a part thereof.

Section 3. FILING. The Villago Clerk is hereby directed to file certified copies of this Ordinanco with the Minnesota Municipal Commission. the Secretory of State, and the County Auditor.

Section 4. EFFECTIVE DATE. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed herein.
