To H. C. Beecher, County Auditor of the County of Aitkin,
State of Minnesota:

We, J. F. Neubauer, President, and Geo. A. Reiter,
Clerk of the Village of McGregor in said County of Aitkin
and State of Minnesota, do hereby certify that at the An-
nual Village Election held in said Village on the 11th day
of March, 1919, the question of separation from the Town-
ship of McGregor was voted upon and carried by a majority
of the ballots cast. That the following is a copy of the
certified report given by the Judges of Election to the
Village Council, to-wit:

"We, Grover Wurzbarger and Wm. Beidleman, Judges of
Election at the Annual Election held in the Village of
McGregor, in the County of Aitkin and State of Minnesota,
on the 11th day of March, 1919, do hereby certify that
the question of the separation of the Village from the
Township was plainly submitted to the voters in the notice
of said election and that the following was the form of
ballot used, to-wit:

Shall the Village of McGregor become	Yes	<input type="checkbox"/>
and be a separate election and assess-		
ment district, and in all things separate	No	<input type="checkbox"/>
from the Township of McGregor?		

That at the above mentioned election, which was held in the
Village Hall in said Village, there were 31 ballots cast of
which 29 were "yes" and 2 were "no."

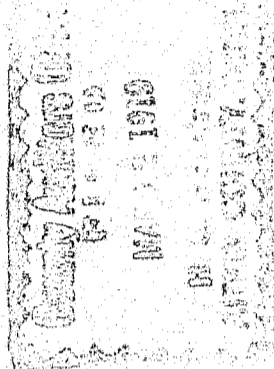
