AN ORDINANCE OF ANNEXATION

THE CITY COUNCIL of the City of Tracy, Minnesota, do ordain:

SECTION 1. That Northern States Power Company has petitioned the City Council in accordance with the provisions of Minnesota Statutes Annotated, Section 414.03, for annexation to the City of Tracy, the tracts or parcels of land lying and being in the County of Lyon, State of Minnesota, described as follows, to-wit:

All that part of the Southwest Quarter (SW¹/₄) of the Southwest Quarter (SW¹/₄) of Section Fourteen (14), Township One Hundred Nine (109), Range Forty (40) Lyon County, Minnesota, included in and bounded as follows: Beginning at a point Thirty Three (33) feet North and Thirty Three (33) feet East of the Southwest corner of said Southwest Quarter of the Southwest Quarter (SW¹/₄SW¹/₄) of Section 14, thence east along the North line of the highway a distance of One Hundred (100) feet; thence at right angles North a distance of Two Hundred Seventeen and eight-tenths (217.8) feet; thence at right angles west and parallel to the first named course a distance of One Hundred (100) feet, to the East line of the highway; thence at right angles south and along said East line of highway a distance of Two Hundred Seventeen and eight-tenths (217.8) feet to the point of beginning; and containing one-half (1/2) acre.

SECTION 2. That pursuant to the petition of the Northern States Power Company, and in accordance with the provisions of Minnesota Statutes Annotated, Section 414.03, the City Council of the City of Tracy, do hereby annex to the City of Tracy the premises above described including all legal highways adjoining said City of Tracy and said above described premises.
