ORDINANCE NO. 131

AN ORDINANCE PROVIDING FOR ANNIXATION OF CERTAIN LAND ABUTTING THE VILLAGE UPON PETITION OF ALL OF THE OWNERS OF SUCH LAND

THE VILLAGE COUNCIL OF DELANO, MINNESOTA, ORDAINS:

Section 1) That pursuant to a position by all of the owners of certain property comprising less than two hundred (200) agres, legally described as follows:

The West 30 feet of Lot D according to the plat of record of the Northeast Quarter of the Northwest Quarter of Section 13, Township 115, Range 25, in said Wright County, Minnesota;

and also,

Lots B and C according to the plat of record of the Northeast Quarter of the Northwest Quarter of Section 13, Township 113, Range 25, Wright County, Minnesota, except that part of Lot B lying North of a line drawn Westerly from a point on the East line of Lot C a distance 278.1 feet South of the Northeast corner thereof to a point on the West line of Lot B, a distance 281.0 feet South of the Northwest corner thereof, said line being 215 feet Southerly of and parallel with the present Southerly right-of-way line of U. S. Highway No. 12,

the village council has unanimously determined that it is to the best interest of the village and to the best interest of the property to be annexed that it be annexed.

Section 2) The tract hereinbefore described is, by this ordinance, declared to be amnexed to the Villago of Delano, Minnesota.
