

AN ORDINANCE ANNEXING "JAMES B. HENDRYX ADDITION"
TO THE CITY OF SAUK CENTRE

Section 1. That the following described platted area adjoining the limits of the City of Sauk Centre, and is located in the County of Stearns, State of Minnesota; and the owners thereof having petitioned the said City to have the said land annexed, the said land is hereby added to, taken into and made a part of the City of Sauk Centre.

James B. Hendryx Addition, to the City of Sauk Centre, part of the Southwest Quarter (SW $\frac{1}{4}$) and of the West half of the West half (W $\frac{1}{2}$ W $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section 4, Township 126, North, Range 34 West, Stearns County, Minnesota.

Section 2. That on the taking effect of this ordinance, limits and boundary lines of the City of Sauk Centre shall include the aforesaid property.

Section 3. That of the land described in this ordinance, block one of the said James B. Hendryx Addition is hereby assigned to and made a part of the R-1 District insofar as the Zoning ordinance of the City is concerned.

Section 4. That this ordinance shall take effect and be in force 30 days after its publication in the official City paper.

The foregoing Ordinance was duly passed and adopted at a meeting of the Council of the said City, held on the 11th day of February, 1963.
