

ORDINANCE NO. 197  
AN ORDINANCE EXTENDING  
THE CORPORATE LIMITS OF THE  
CITY OF EAST GRAND FORKS  
TO INCLUDE CERTAIN UNPLAT-  
TED LAND ABUTTING THE  
CORPORATE LIMITS OF THE  
CITY OF EAST GRAND FORKS,  
LOCATED IN THE NE¼ OF THE  
NE¼ OF SECTION 34, TOWNSHIP  
ONE HUNDRED FIFTY-TWO,  
NORTH OF RANGE FIFTY,  
TOTTALLING 2.69 ACRES, MORE  
OR LESS.

The City Council of the City of  
East Grand Forks do hereby ordain  
as follows:

Section 1. The corporate limits of  
the City of East Grand Forks,  
Minnesota, are hereby extended to  
include the tract of land herein-  
after described. Said tract of land  
abuts the corporate limits of the  
City of East Grand Forks, and is  
described as follows:

All that part of the Northeast  
Quarter of the Northeast Quarter  
(NE¼NE¼) and Government  
Lot One (1), in Section Thirty-  
Four (34), Township One Hund-  
red Fifty-two (152) North of  
Range Fifty (50), West of the  
Fifth Principal Meridian, describ-  
ed as follows:

Commencing at a point on the  
section line between Section 34  
and 35 in said Township which  
is 1016 feet south of the corner  
common to Sections 26, 27, 34  
and 35 of said Township 152  
North, Range 50, West of the  
Fifth Principal Meridian; thence  
due west to the Red River of  
the North; thence North along  
said river to a point 40 feet per-  
pendicularly north of the first  
east-west course herein describ-  
ed; thence east parallel with and  
40 feet distant from said first  
east-west course herein describ-  
ed to the East line of said Sec-  
tion 34; thence south along the  
East line of said Section 34 a dis-  
tance of 40 feet to the point of  
beginning.

Section 2. The total quantity of  
land embraced within the descrip-  
tion of the said tract is 2.69 acres,  
more or less, and the sole owner  
thereof is the said City of East  
Grand Forks, Minnesota.

Section 3. The City Council here-  
by determines: (1) That said tract  
of land abuts the corporate limits  
of the City of East Grand Forks,  
and is not included within the  
corporate limits of any other mun-  
icipality; (2) That the annexation  
will be to the best interests of the  
City of East Grand Forks, Minn-  
esota, and of the territory affected;  
(3) That said tract of land is suit-  
ably conditioned for municipal  
government; (4) That said tract of  
land is urban in character.

Section 4. The corporate limits of  
the City of East Grand Forks,  
Minnesota, are hereby extended to  
include the tract of land described  
in Section 1, and the same is here-  
by annexed to and included in the  
City of East Grand Forks, Minn-  
esota, as effectually as if it had  
originally been a part thereof.

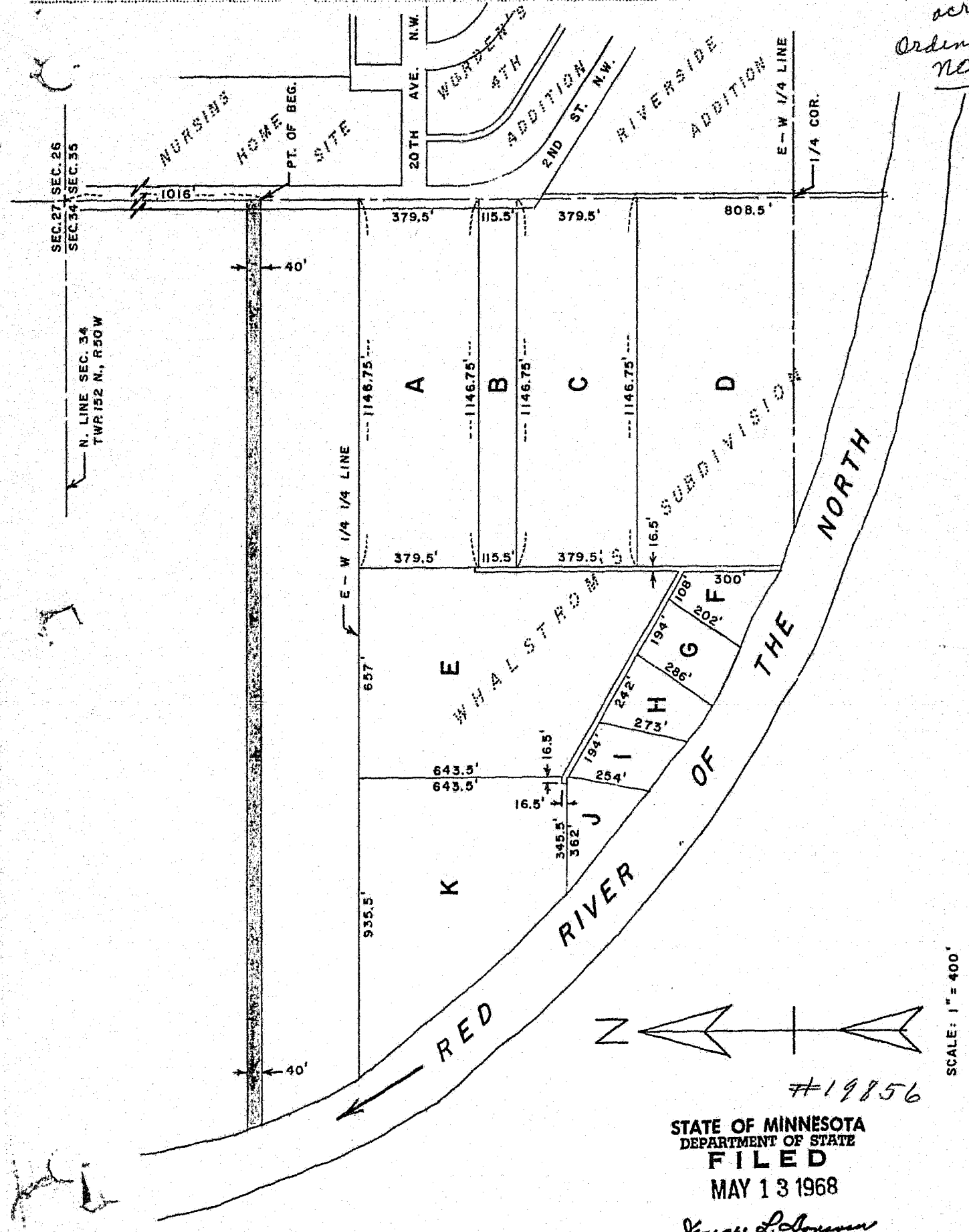
