

AN ORDINANCE RELATING TO THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF ALEXANDRIA, MINNESOTA, DECLARING THE WARD TO WHICH IT SHALL BE ATTACHED, AND EXTENDING THE CORPORATE LIMITS TO ENCOMPASS SAID LAND

WHEREAS, The City of Alexandria has purchased forty-five (45) acres more or less, lying in Government Lot Two (2), Section Twenty-five (25), Township One Hundred Twenty-eight (128), Range Thirty-eight (38) West of the 5th P.M., the City of Alexandria being now the record owner of said property, and

WHEREAS, said property abuts upon the existing corporate limits of the City of Alexandria, and

WHEREAS, said property will be used for municipal purposes,

NOW, THEREFORE, the City Council of the City of Alexandria does ordain:

Section I. That the following described land, to-wit:

All that part of Government Lot 2, Section 25, Township 128 North, Range 38 West of the 5th P.M. lying East and South of the following described line; commencing at the Southwest corner of Government Lot 2, Section 25, Township 128 North, Range 38 West of the 5th P.M., thence North along the west line of said Government Lot 2, 1200 feet; thence at an angle of 45° East from the West line of said Government Lot 2 to the shore line of Lake Winona; thence Easterly along the shore line of Lake Winona to the East line of Government Lot 2 and there terminating, containing 45 acres more or less,

is hereby annexed to and made a part of the Municipality of the City of Alexandria, Minnesota, and the corporate limits of the City of Alexandria, Minnesota, shall be and the same hereby are extended to include and encompass the land and territory above described.

Section II. All of said land and territory described by limits, descriptions and boundaries in Section I above and hereby annexed to and made a part of the City of Alexandria, Minnesota, shall be and does hereby become a part of the Fifth Ward of the City of Alexandria.

SECTION III. This ordinance shall take full force and effect from and after its passage and publication in accordance with the

laws of the State of Minnesota, and the Charter of the City of Alexandria, and upon the filing of a copy of this Ordinance with the Minnesota Municipal Commission, the Auditor of Douglas County, Minnesota, and the Secretary of State of the State of Minnesota.
