

CHAPTER XV

ORDINANCE NO. 150 - F

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SARTELL TO INCLUDE UNINCORPORATED PROPERTY ADJUTING UPON THE VILLAGE LIMITS AND NOT EXCEEDING 200 ACRES IN AREA.

WHEREAS a certain petition dated March 4th 1933, requesting annexation of the territory hereinafter described was duly presented to the Village of Sartell on the 4th day of March 1933; and,

WHEREAS the quantity of land embraced within the area described in the petition and bounded as described is not in excess of 75 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and, WHEREAS the petition was signed by all of the owners of said land; and,

WHEREAS no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and,

WHEREAS the land described in the petition abuts upon the Village limits on the westerly side thereof, THIS, THEREFORE:

THE COUNCIL OF THE VILLAGE OF SARTELL, MINNESOTA, ORDAINS AS FOLLOWS:

Subsection 1. The Village Council hereby determines that the annexation will be to the best interest of the Village and of the territory affected; that the territory described herein abuts upon the Village limits and is about to become urban or suburban in character; and that none of said territory is now included within the limits of any City, Village or Borough.

Subsection 2. Territory Annexed. The corporate limits of the Village of Sartell are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof, to-wit:

"The Northwest Quarter of the Northwest Quarter (NW¹/₄ NW¹/₄) and the Northeast Quarter of the Northwest Quarter (NE¹/₄ NW¹/₄) less the following tract of land lying and being in the Northeast Quarter of Northwest Quarter, as follows: Commencing at the Northeast Corner of said NE¹/₄ NW¹/₄; thence West-erly on North line of said Quarter a distance of 21 rods; thence at right angles South and parallel with the East line of said Quarter a distance of 16 rods; thence at right angles East and parallel with the North line of said Quarter a distance of 21 rods to the East line of said Quarter; thence North along the East line of said Quarter a distance of 16 rods to the place of beginning, all being in Section Twenty-One (21), Township One Hundred Twenty-Five (125) North, Range Twenty-Eight (28) West, Stearns County, Minnesota."

Subsection 3. Filing. The Village Clerk is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of Stearns County and the Minnesota Municipal Commission.

Subsection 4. Effective Date of Annexation. This ordinance takes effect upon the passage and publication and the filing of the certified copies as directed in Subsection 3 above.


