

ORDINANCE NO. 189

AN ORDINANCE TO ANNEX THE FOLLOWING DESCRIBED PROPERTY TO THE CITY OF GLENCOE, NAMELY:- BEGINNING AT A POINT ON THE WEST LINE OF SECTION THIRTEEN (13), SAID POINT BEARING NORTH $0^{\circ}30'$ EAST NINE HUNDRED FORTY-TWO AND SEVEN TENTHS (942.70') FEET FROM THE SOUTHWEST CORNER OF SECTION THIRTEEN (13), THENCE, SOUTH $89^{\circ}30'$, EAST A DISTANCE OF ONE HUNDRED FORTY (140.0) FEET, THENCE, NORTH $18^{\circ}44'$ EAST A DISTANCE OF EIGHTY-NINE AND FORTY-NINE HUNDREDTHS (89.49) FEET TO THE NORTHERLY BOUNDARY LINE OF LOT NINETY-NINE (99), THENCE ALONG SAID BOUNDARY LINE NORTH $89^{\circ}30'$ WEST A DISTANCE OF ONE HUNDRED SIXTY-EIGHT (168.0) FEET TO THE WEST LINE OF SECTION THIRTEEN (13), THENCE, ALONG SAID WEST LINE SOUTH $0^{\circ}30'$ WEST A DISTANCE OF EIGHTY-FIVE (85.0) FEET TO THE POINT OF BEGINNING.

The City Council of the City of Glencoe ordains:

Section 1. That the following described tract of land which abuts upon the incorporated limits of the City of Glencoe be and the same hereby is annexed to the City of Glencoe and the same shall be a part of said City as effectually as if it had originally been a part thereof, namely:-

A part of Lot Ninety-Nine (99) of Rearrangement of Outlot "A" and lots 42-43-44-47-75 of "GLENVIEW WOODS" All in Section Thirteen (13) Township One Hundred Fifteen North (115N) Range Twenty-Eight West (28W), McLeod County, Minnesota. Described as follows:

Beginning at a point on the West line of Said Section Thirteen (13), said point bearing North $0^{\circ}30'$ East Nine Hundred Forty-Two and Seven Tenths (942.70') feet from the Southwest Corner of SECTION Thirteen (13), Thence, South $89^{\circ}30'$ East a distance of one Hundred Forty (140.0) feet, Thence, North $18^{\circ}44'$ East a distance of Eighty-Nine and Forty-Nine Hundredths (89.49) feet to the Northerly Boundary Line of said Lot Ninety-Nine (99), Thence along said Boundary Line North $89^{\circ}30'$ West a distance of One Hundred Sixty-Eight (168.0) feet to the West line of Section Thirteen (13), Thence, along said West line South $0^{\circ}30'$ West a distance of Eighty-Five (85.0) feet to the point of beginning.

Section 2. This ordinance shall be in force and effect from and after its passage and publication.
