AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF FARIBAULT TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated February 6th, 1968, requesting annexation of the territory hereinafter described was duly presented to the Council on the 13th day of February, 1968; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 111 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all of the owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the South boundary thereof;

The Counci. of the City of Faribault do ordain:

Section 1. DETERMINATION OF NEED. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is/or is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. TERRITORY ANNEXED. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed and added to, included within, and made a part of the City as effectually as if it had originally been a part thereof, to-wit:

The West Half (W2) of the Southwest Quarter (SW2), in Section 6, Township 109, North of Range 20 West, except to railway and except that part thereof described as follows: Beginning at the Southwest Corner of said Section, said point being the point of beginning, and running thence North along the West line of said Section, a distance of 272.25 feet, and thence East and parallel to the South line of said Section, a distance of 160 feet, and thence South and parallel to the West line of said Section 272.25 feet, and thence West along the South line of said Section to the Southwest Corner of said Section, being the point of beginning, containing 1 acre.

All that part of the South One-Half (S1) of the Southeast Quarter (SE%) of Section 1, Township 109 North, Range 21 West, lying South of the right-of-way of the Chicago, Milwaukee and St. Paul Railway Company, except for that part thereof described as: (1) Beginning at a point in the East line of the said South Half (S%) of the Southeast Quarter (SE%) of Section 1, 302 feet Northerly of the Southeast Corner of said Section 1, thence Westerly at right angles to the said East line 213 feet; thence Northerly, parallel to the said East line 90 feet; thence Westerly at right angles 213 feet; thence Northerly at right angles 137 feet; thence Easterly at right angles 213 feet; thence Northerly at right angles 128.6 feet; thence Easterly at right angles 213 feet to said East line; thence Southerly 355.6 feet to the point of beginning.

Section 3. FILING. The City Recorder is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. EFFECTIVE DATE. This ordinance takes effect ten (10) days after its passage and publication and the filing of the certified copies as directed in Section 3 above.
