

ORDINANCE NO. 508

AN ORDINANCE ANEXING PART OF THE NORTHEAST QUARTER OF NORTHEAST QUARTER (NE $\frac{1}{4}$ of NE $\frac{1}{4}$), SECTION 25, TOWNSHIP 41, RANGE 21, PINE COUNTY, MINNESOTA, TO VILLAGE OF HINCKLEY

The Village Council of Hinckley ordains:

Section I: WHEREAS, the Village of Hinckley is the owner of the hereinafter described premises:

A tract of land in the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$) of Section 25, Township 41 North, Range 21 West of the 4th Principal Meridian, Pine County, Minnesota, more particularly described as follows, to-wit: Beginning at the Northwest corner of said NE $\frac{1}{4}$ of NE $\frac{1}{4}$, thence East on the North line thereof a distance of 217.0 feet, thence South parallel to the West line of said NE $\frac{1}{4}$ of NE $\frac{1}{4}$, a distance of 396.0 feet, thence West parallel to the North line of said NE $\frac{1}{4}$ of NE $\frac{1}{4}$, a distance of 217.0 feet, thence North a distance of 396.0 feet to the point of beginning, Pine County, Minnesota.

and

Section II: WHEREAS, the said above described premises abuts on the Village of Hinckley on two sides and is not included in any other municipality, and

Section III: WHEREAS, the Village of Hinckley wishes to annex said above described premises to the Village of Hinckley,

Section IV: BE IT HEREBY ORDAINED, that the Village of Hinckley pursuant to Minnesota Statutes Annotated 414.03, Subd. 2, does hereby annex said above described premises to the Village of Hinckley.

Section V: This Ordinance becomes effective from and after its passage and publication.
