
Dear Mr. Jessen:

ORDINANCE NUMBER 104  
VILLAGE OF FOLEY  
BENTON COUNTY MINNESOTA

WHEREAS, a certain petition dated March 20, 1968, requesting annexation of the territory hereinafter described was duly presented to the Council on the second day of April, 1968; and

WHEREAS, the quantity of land appraised within the area described in the petition and bounded as described is approximately Three and one-half (3½) acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all of the owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits;

THE COUNCIL OF THE VILLAGE OF FOLEY MINNESOTA ORDAINS AS FOLLOWS:

That the 1967 Code of Ordinances of the Village of Foley be amended by adding Chapter Ten, Section 100:01 to read as follows:

Section 100:01 (1).

The Village Council hereby determines (1) that the annexation will be to the best interest of the Village and to the territory affected; (2) that the territory described herein abuts upon the village limits and is suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 100:01 (2) Territory Annexed.

The corporate limits of the Village are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof:

All that part of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$  of NE $\frac{1}{4}$ ), Section Thirty-five (35), Township Thirty-seven (37), Range Twenty-nine (29) West, described as follows: Commencing at the Northwest (NW) corner of Lot Eighteen (18), Block One (1), Foley Development Plat as shown on the plat thereof which is on file and of record in the office of the Register of Deeds in and for said Benton County, Minnesota, said point being on the Easterly right-of-way line of State Highway #25; thence Northerly on said right-of-way line 195.0 feet to point of beginning; thence continue Northerly on said right-of-way line 400.0 feet; thence Easterly parallel to Northerly boundary line of said Foley Development Plat 400.0 feet; thence Southerly parallel to said Easterly right-of-way line of State Highway #25, 400.0 feet; thence Westerly parallel to said Northerly boundary line of Foley Development Plat 400.0 feet to point of beginning, which is of record in the name of Charles-Roy Company, a Minnesota Corporation.

Section 100:01 (3) Filing.

The Village Clerk is hereby directed to file certified copies of this Ordinance with the Municipal Commission, Secretary of State, and the County Auditor.

Section 100:01 (4) Effective Date.

This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 100:01 (3).
